1. **CALL TO ORDER:** The meeting was called to order at 7:05 p.m. by Mayor Wayne Slaton.
2. **ROLL CALL:** Town Clerk Debra Eastman called the roll with the following Council members present: Robert Meador, Richard Pulido, Nancy Simon, Roberto Alonso, and Mayor Wayne Slaton. Councilmember Michael Pizzi arrived at 7:10 p.m. Vice Mayor Mary Collins was absent.
3. **PLEDGE OF ALLEGIANCE:** The Mayor led the Pledge of Allegiance.

A. A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, (APPROVING / DENYING) REQUESTED VARIANCE(S) FILED IN ACCORDANCE WITH THE TOWN DEVELOPMENT CODE TO PERMIT AN ACCESSORY BUILDING TO A SINGLE FAMILY RESIDENCE:

C. A RESOLUTION OF THE TOWN COUNCIL [APPROVING/ DENYING] A VARIANCE FILED IN ACCORDANCE WITH DIVISION 3.5 OF THE TOWN LAND DEVELOPMENT CODE TO (1) WAIVE SECTION 5.2.A.3 OF THE LAND DEVELOPMENT CODE TO PERMIT AN ACCESSORY CHICKEE HUT IN THE RU-1 DISTRICT WITH A 3 FOOT REAR SETBACK WHERE 5 FEET IS

REQUIRED; AND (2) WAIVE SECTION 5.2.A.3 OF THE LAND DEVELOPMENT CODE TO PERMIT AN ACCESSORY CHICKEE HUT IN THE RU-1 DISTRICT WITH A 4 FOOT INTERIOR SIDE SETBACK WHERE 5 FEET IS REQUIRED (COLLECTIVELY, "THE VARIANCES"), FOR A SINGLE FAMILY RESIDENCE LOCATED AT 14270 SABAL DRIVE, MIAMI LAKES, FLORIDA; PROVIDING FINDINGS; PROVIDING FOR [APPROVAL / DENIAL]; PROVIDING CONDITIONS OF APPROVAL. (Rey)

Town Attorney, Melissa Anderson read a statement giving information regarding the quasi-judicial proceedings. Town Clerk, Debra Eastman asked that anyone in the audience wishing to testify at this meeting stand. The Town Clerk administered the oath.

Ms. Anderson read the title of the resolution into the record. Director of Planning and Zoning, Maria Crowley explained the variance, including the conditions. Ms. Bautista spoke in favor of the variance and offered photographs. In response to a question from Mayor Slaton, Ms. Bautista stated that the conditions were agreeable. There being no one else wishing to speak, the Mayor closed the public hearing.

Councilmember Nancy Simon made a motion for approval of the resolution, including the conditions. The motion received a second from Councilmember Robert Meador. The Mayor called for the vote and all were in favor.

D. A RESOLUTION OF THE TOWN COUNCIL [APPROVING/DENYING] REQUESTED VARIANCE(S) FILED IN ACCORDANCE WITH DIVISION 3.5 OF THE TOWN CODE TO PERMIT A NEW METAL ROOF (THE "VARIANCE"), FOR PROPERTY LOCATED AT 8553 N.W. 164th STREET, MIAMI LAKES, FLORIDA; PROVIDING FINDINGS; PROVIDING FOR [APPROVAL/DENIAL]; PROVIDING CONDITIONS OF APPROVAL. (Rey)

Town Attorney, Melissa Anderson read the title of the resolution into the record. Director of Planning and Zoning, Maria Crowley, explained the request and gave her recommendation to the Council.

Mayor Slaton opened the public hearing and Ms. Whitefield spoke in favor. She explained the hurricane damage and the roof material to be used. She presented a sample of the material, photos of the damage and a petition from her neighbors stating they are in favor of the variance. There being no other speakers, the Mayor closed the public hearing.

Councilmember Roberto Alonso moved for passage of the resolution and it was seconded by Councilmember Nancy Simon. The Mayor called for the vote and all were in favor.

E. A RESOLUTION OF THE TOWN COUNCIL [APPROVING/ DENYING] VARIANCES FILED IN ACCORDANCE WITH DIVISION 3.5 OF THE TOWN LAND DEVELOPMENT CODE TO PERMIT (1) ACCESSORY STORAGE OF BOATS, PERSONAL WATERCRAFT OR BOAT TRAILER OUTSIDE OF A RESIDENTIAL GARAGE; AND (2) ACCESSORY STORAGE OF A BOAT, IN

THE RU-1Z DISTRICT WITH A 0 FOOT SIDE YARD SETBACK WHERE 2 FEET IS REQUIRED (COLLECTIVELY, "THE VARIANCES"), FOR PROPERTY LOCATED AT 9013 N.W. 144 TERRACE, MIAMI LAKES, FLORIDA. (Rey)

Town Attorney, Melissa Anderson, read the title of the resolution into the record. Planning and Zoning Director, Maria Crowley, explained the need for a variance for storage of the boat.

Attorney for Ms. Vilches, Paul Kineski spoke in favor of the variance. He presented photos of the boat storage and presented a petition from the neighbors in approval. Ms. Vilches also spoke in favor of the variance. There being no other speakers, Mayor Slaton closed the public hearing.

Councilmember Michael Pizzi made a motion to approve the resolution. It was seconded by Councilmember Nancy Simon. Councilmember Michael Pizzi spoke in favor of granting the approval.
