

**RESOLUTION NO. 11-891**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING THE REQUEST OF ROLANDO PRIETO TO REDUCE A PREVIOUSLY ASSESSED CODE COMPLIANCE FINE FOR CASE NO. C2010-0211; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Miami Lakes (the "Town"), through its Code Compliance Department, issued Citation No. C2010-0211 ("Citation") to Rolando Prieto (the "Owner"); and

**WHEREAS**, a Citation was issued and the violation was subsequently corrected by Owner; and

**WHEREAS**, the Owner has incurred a fine of \$11,673.25; and

**WHEREAS**, the Owner has requested that the Town reduce the fine and the Town Manager having reviewed the file has recommended to the Town Council approval of a reduction of the fine of \$11,673.25, leaving a balance to be paid in the amount of \$3,000; and

**WHEREAS**, the Owner has agreed to sign a release of the Town from any claims relating to the Citation as a condition of the reduction.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1.    Recitals.**    The above recitals are true and correct and are incorporated herein by this reference.

**Section 2.    Reduction of Fine.**    The civil penalty/fine for Code Compliance Case No. C2010-0211 is reduced to \$3,000.00 subject to the Owner paying the reduced amount no later than 60 days from the effective date of this Resolution. The Town Manager

is authorized to execute appropriate documents, including a release and waiver by the Owner for any and all claims relating to the Citation and this reduction.

**Section 3. Conditions.** In the event the reduced fine is not paid within sixty (60) days of the effective date of this Resolution, the original fine amount shall be reinstated and continue to accrue interest as if this Resolution had not existed.


**Section 4. Effective Date.** This Resolution shall be effective immediately upon adoption.


