

ORDINANCE NO. 13-162

AN ORDINANCE OF THE TOWN OF MIAMI LAKES, FLORIDA, AMENDING ORDINANCE NO. 05-66, 05-76 AND 08-100; ADOPTING A REVISED BUILDING PERMIT FEE SCHEDULE; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in January of 2005, the Town Council adopted a Building Permit Fee Schedule for the Building Department in Ordinance No. 05-66 and amended the same in Ordinance No. 05-76 and Ordinance No. 08-100; and

WHEREAS, the Town Council finds that it is in the best interests of the residents of the Town to adopt the following amendments to the Building Permit Fee Schedule, replacing the existing Building Permit Fee Schedule in its entirety.

NOW THEREFORE, IT IS HEREBY ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Amendments to Building Permit Fee Schedule. The Building Permit Fee Schedule attached as Attachment A shall replace in its entirety the Building Department Permit Fee Schedule currently adopted in Town Ordinance No. 05-66 and amended in Ordinance No. 05-76 and in Ordinance No. 08-100.

Section 2. Severability. The provisions of this ordinance are declared to be severable and if any section, sentence, clause or phrase of this ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases of this ordinance but they shall remain in effect, it being the legislative intent that this ordinance shall stand notwithstanding the invalidity of any part.

Section 3. **Inclusion In The Code.** It is the intention of the Town Council that the provisions of this ordinance shall become and be made a part of the Code of Miami Lakes, Florida. The sections of this ordinance may be renumbered or relettered to accomplish such intention, and the word “ordinance” may be changed to “section,” “article,” or other appropriate word.

Section 4. **Effective Date.** This Ordinance shall be effective immediately upon its adoption on second reading.

The foregoing Ordinance was offered by Vice Mayor Manny Cid, who moved its adoption on first reading. The motion was seconded by Councilman Tim Daubert and upon being put to a vote, the vote was as follows:


