

RESOLUTION NO. 03- 184

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE SELECTION OF CASEY'S LANDSCAPING, INC. FOR INSTALLATION OF SOD AT ROYAL OAKS PARK; AUTHORIZING TOWN OFFICIALS TO FINALIZE THE TERMS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, over the past year, the Town of Miami Lakes (the "Town") has been making the planned improvements to Royal Oaks Park (the "Park"); and

WHEREAS, the Town is in need of a contractor to install sod along the perimeter of the Park (the "Services"); and

WHEREAS, the Town obtained bids from three (3) contractors for the Services; and

WHEREAS, Casey's Landscaping, Inc. ("Casey's") was the lowest bidder at \$16,902 for installing 90,000 square feet of sod; and

WHEREAS, the Town Manager recommends the selection of Casey's for the Services at the Park.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. Award of Contract. The contract for sod installation at Royal Oaks Park shall be awarded to Casey's Landscaping, Inc.

Section 3. Authorization of Town Officials. The Town Manager and Town Attorney are authorized to take all steps necessary to finalize the contract with Casey's.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the contract.

Section 5. Execution of Contract. The Mayor is authorized to execute the contract on behalf of the Town.


Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.


