

RESOLUTION NO. 04-~~205~~

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AWARDED THE MISCELLANEOUS ROADWAY STRIPING BID TO UNITED RENTALS HIGHWAY TECH, INC. AND APPROVING THE AGREEMENT; AUTHORIZING TOWN OFFICIALS TO TAKE ALL STEPS NECESSARY TO FINALIZE THE TERMS OF THE AGREEMENT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT ON BEHALF OF THE TOWN; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, for the past year, the Town of Miami Lakes (the “Town”) has been providing roadway striping services (“Roadway Striping”) throughout the Town’s streets through H and R Paving, under the “Miscellaneous Public Works” contract, which expired on February 24, 2004; and

WHEREAS, the Town publicly advertised bids for Roadway Striping, which were available to contractors on January 27, 2004; and

WHEREAS, four (4) bids were received and on February 17, 2004, bids were publicly opened; and

WHEREAS, the Town Manager recommends the selection of United Rentals Highway Tech, Inc. (“United Rentals”) as the lowest bid; and

WHEREAS, the Town Council finds that approving the contract with United Rentals for Roadway Striping is in the best interest of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. Approval of Agreement. The bid for miscellaneous roadway striping is awarded to United Rentals Highway Tech, Inc. and Agreement for Roadway Striping within the Town between the Town of Miami Lakes and United Rentals Highway Tech, Inc. (the "Agreement"), a copy of which is attached as Exhibit "A," together with such non-material changes as may be acceptable to the Town Manager and approved as to form and legality by the Town Attorney, is approved.

Section 3. Authorization of Town Officials. The Town Manager and Town Attorney are authorized to take all actions necessary to implement the terms and conditions of the Agreement.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Agreement.

Section 5. Execution of Agreement. The Mayor is authorized to execute the Agreement on behalf of the Town.


Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.

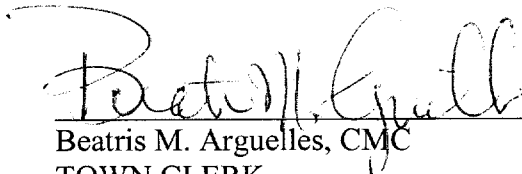
