

**RESOLUTION NO. 05-329**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, DESIGNATING NORTHWEST 79<sup>TH</sup> COURT BETWEEN NORTHWEST 154<sup>TH</sup> STREET AND COMMERCE WAY AS “GOVERNOR BOB GRAHAM” PARKWAY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Honorable Bob Graham has resided in the Town of Miami Lakes for over forty years: and

**WHEREAS**, Bob Graham has served as a distinguished leader of the state serving as Governor of the State of Florida and as a United States Senator; and

**WHEREAS**, in recognition of his direct, significant, lifetime contribution to the community, the Town Council desires to designate Northwest 79<sup>th</sup> Court between Northwest 154<sup>th</sup> Street and Commerce Way as “Governor Bob Graham” Parkway; and

**WHEREAS**, pursuant to Section 2-1, Rule 9.02 of the Town Code (Miami-Dade County as made applicable to the Town pursuant to the Town Charter) the Town Council has held a public hearing to consider the designation of the roadway.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1.**     **Recitals.** The foregoing Recitals are true and correct and are incorporated herein by this reference.

**Section 2.**     **Designation of Roadway.** Northwest 79<sup>th</sup> Court between Northwest 154<sup>th</sup> Street and Commerce Way is designated “Governor Bob Graham” Parkway.

**Section 4. Street Designation.** The Town Clerk is directed to send a certified copy of this resolution to the United States Postal Service in order to verify the street designation for postal records.


**Section 5. Effective Date.** This Resolution shall take effect immediately upon its adoption.
