Councilmember Marilyn Ruano joined at 9:12 AM. Councilmember Carlos Alvarez was absent. Present as well were: The Town Manager, Ed Pidermann, Town Attorneys, Raul Gastesi, Lorenzo Cobiella, and Raul Lopez from Gastesi, Lopez and Mestre, PLLC; and the Certified Court Reporter.

3. PLEDGE OF ALLEGIANCE:

Town Attorney Raul Gastesi led the pledge of allegiance.

4. INVOCATION:

Attorney Raul Lopez led the of the invocation.

5. Public Meeting Session:

Mayor Manny Cid read into the record the following statement:

Mayor Manny Cid also read into the record that the following statement:

"that Section 286.011(8), Florida Statutes provides an exemption from the public meetings law in order to allow the Town Council to conduct a closed session to discuss strategy related to litigation expenditures and/or settlement negotiations in a pending lawsuit. This is what the Town Council will be doing today. This session will be recorded by a court reporter. The transcript will be filed with the Town Clerk and it will remain sealed until the conclusion of the litigation. When the litigation has concluded, the transcript becomes public record and can be requested by anyone. This attorney-client session is estimated to last one hour.
