### **Town of Miami Lakes C&LS Refund Policy**

### For Pavilion, Indoor Facility, and Athletic Field Rentals

- 1. The Town must receive a written request for a cancellation and the following service fees apply for refunds for Pavilion, Indoor Facility, and Athletic Field Rentals:
  - If written notice of cancellation is received by the Town at least two (2) weeks in advance of the reserved date, a refund will be issued that is subject to a \$25 service fee.
  - If written notice of cancellation is received by the Town with less than two (2) weeks in advance of the reserved date, a refund will be issued that is subject to a \$50 service fee (\$25 for small pavilions).
- 2. Amusement administration fee is non-refundable regardless of approval or non-approval.
- 3. Fees will be upheld regardless of weather conditions. Severe weather conditions are exceptions. If the weather is deemed unsafe by an employee of the Town of Miami Lakes, the rental fee will be refunded upon request no later than three (3) business days after the event date. Rescheduling of the reservation will be allowed under these same conditions.

# For Town Operated Programs

Refund requests must be made, in writing, seven (7) days prior to the start of the registered program date and will be subject to a \$15 service fee and any applicable program costs (i.e. uniforms, trip fees, materials, etc.). There will be no refunds when a request is submitted with less than a 7 day notice.

Requests for medical reasons (i.e. broken bone, hospitalization, etc.) will only be accepted with proper documentation

No refunds allowed once the registered program concludes.

## **Online E-Trak Privacy Policy**

**What information do we collect?** We collect information from you when you register on our site, place an order, subscribe to our newsletter, respond to a survey or fill out a form. When ordering or registering on our site, as appropriate, you may be asked to enter your: name, e-mail address, mailing address, phone number or credit card information. Internet cart allows the Town's customers to use the software but they are severely restricted by what they can do. The customer can only access information about themselves or people that the client has listed as in their family and they cannot send any emails to anyone other than the client.

**How do we protect your information?** We implement a variety of security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your personal information.

2. We offer the use of a secure server. All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our Payment gateway providers database only to be accessible by those authorized with special access rights to such systems, and are required to keep the information confidential.

After a transaction, your private information that is collected (credit cards, social security numbers, financials, etc.) may be kept on file indefinitely.

**Do we use cookies?** Yes (Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the sites or service providers systems to recognize your browser and capture and remember certain information. We use cookies to help us remember and process the items in your shopping cart and understand and save your preferences for future visits.

**Do we disclose any information to outside parties?** We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information. This does not include trusted third parties who assist us in operating our website, conducting our business, or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others rights, property, or safety. However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.

#### **Children's Online Privacy Protection Act Compliance**

We are in compliance with the requirements of COPPA (Children's Online Privacy Protection Act), we do not collect any information from anyone under 13 years of age. Our website, products and services are all directed to people who are at least 13 years old or older.
