ORDINANCE NO. 22-304

AN ORDINANCE OF THE TOWN OF MIAMI LAKES, FLORIDA, AMENDING **ORDINANCE** NO. 21-285 AMENDING THE TOWN'S FISCAL YEAR 2021-2022 BUDGET AS AMENDED BY ORDINANCE 22-292, AND AMENDED BY ORDINANCE 22-297; PROVIDING FOR EXPENDITURE PROVIDING OF FUNDS; FOR PROVIDING FOR **AMENDMENTS:** CONFLICTS; AUTHORIZING THE TOWN MANAGER TO TAKE ALL ACTIONS NECESSARY TO IMPLEMENT THE TERMS AND CONDITIONS OF THIS ORDINANCE; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN **EFFECTIVE DATE.**

WHEREAS, in accordance with Section 200.065, Florida Statutes and Section 8.7 of the Town of Miami Lakes (the "Town") Charter, the Town Council adopted Fiscal Year 2021-2022 Budget (the "Budget") by Ordinance 20-285; and

WHEREAS, Ordinance 20-285, has been amended by Ordinance No. 22-292, and 22-297; and

WHEREAS, based upon the review, analysis, and the recommendation of the Town Manager, the Town Council has determined that it is necessary to amend the Budget as set forth in Exhibit "A," attached hereto.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are true and correct and are incorporated herein by this reference.

Section 2. Budget Amendment. The Fiscal Year 2021-2022 Budget adopted in Town Ordinance No. 21-285, and amended by Ordinance 22-292 and Ordinance 22-297, is amended in order to utilize fund balance to fund the projects provided for in Exhibit "A," attached hereto. All other terms and conditions of Town Ordinance No. 21-285, as amended, not otherwise amended by this Ordinance remain in full force and effect.

Section 3. Authorization of Town Manager. The Town Manager is hereby authorized to take all actions necessary to implement the terms and conditions of this Ordinance.

Section 4. Authorization of Fund Expenditures. The Town Manager or his/her designee is authorized to expend or contract for expenditures such funds as are necessary for the operation of the Town government in accordance with the Budget and the terms and conditions of this Ordinance.

Section 5. Conflicts. All sections or parts of sections of the Town Code that conflict with this Ordinance are repealed to the extent of such conflict.

Section 6. Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause, provision, or phrase of this Ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases of this Ordinance, but they shall remain in effect, it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

Section 7. Effective date. This Ordinance shall be effective upon adoption on second reading.
