ORDINANCE NO. 2001-06

AN ORDINANCE OF THE TOWN OF MIAMI LAKES, FLORIDA, ESTABLISHING A SALARY AND BENEFITS FOR THE MAYOR OF THE TOWN; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in accordance with Section 2.6 of the Town Charter the Town Council may establish a salary for the Town Mayor; and

WHEREAS, the Town Council finds that it is in the best interest of the Town to compensate the Mayor.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by reference.

Section 2. Salary and Benefits. The Town Mayor shall receive the following:

- 1. The sum of \$18,000.00 annually payable bi-weekly.
- 2. A monthly car allowance in the amount of \$600.00.
- Individual medical insurance at no cost to the Mayor from the same health insurance plan available to Town employees.
- 4. The Mayor may purchase dependent medical insurance coverage at the Mayor's own expense from the health insurance plan available to Town employees.

Section 3. Severability. The provisions of this Ordinance are declared to be severable and if any section, sentence, clause or phrase of this Ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, sentences, clauses, and phrases of this Ordinance but they shall remain in effect, it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

Section 4. Effective Date. This Ordinance shall become effective upon adoption on second reading. It is further provided that the payment under Section 2, subsection 1, shall be retroactive to March 1, 2001.
