ORDINANCE No. 08- 100

AN ORDINANCE OF THE TOWN OF MIAMI LAKES, FLORIDA, AMENDING ORDINANCE NO. 05-66 AND 05-76; ADOPTING A REVISED BUILDING PERMIT FEE SCHEDULE; PROVIDING A SAVINGS CLAUSE; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CODE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in January of 2005, the Town Council adopted a Building Permit Fee Schedule for the Building Department in Ordinance No. 05-66 and amended the same in Ordinance No. 05-76; and

WHEREAS, the Town Council finds that it is in the best interests of the residents of the Town to adopt the following amendments to the Building Permit Fee Schedule, replacing the existing building permit fee schedule in its entirety.

NOW THEREFORE, IT IS HEREBY ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Amendments to Building Permit Fee Schedule. The Building Permit Fee Schedule attached as Exhibit "A" shall replace in its entirety the Building Department Permit Fee Schedule currently adopted in Town Ordinance No. 05-66 and amended in Ordinance No. 05-76.

Section 2. Savings Clause. All other provisions of Ordinance No. 05-66, as amended by Ordinance No. 05-76, not specifically amended by this Ordinance, replaced or otherwise repealed, shall remain in effect.

Section 3. Severability. The provisions of this ordinance are declared to be severable and if any section, sentence, clause or phrase of this ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections,

sentences, clauses, and phrases of this ordinance but they shall remain in effect, it being the legislative intent that this ordinance shall stand notwithstanding the invalidity of any part.

Section 4. Inclusion In The Code. It is the intention of the Town Council that the provisions of this ordinance shall become and be made a part of the Code of Miami Lakes, Florida. The sections of this ordinance may be renumbered or relettered to accomplish such intention, and the word "ordinance" may be changed to "section," "article," or other appropriate word.

Section 5. Effective Date. This Ordinance shall be effective immediately upon its adoption on second reading.
