

**RESOLUTION NO. 23 - 1946**

**A RESOLUTION OF THE TOWN OF MIAMI LAKES,  
FLORIDA, AUTHORIZING THE RETROACTIVE  
EXTENSION OF AN INTERLOCAL AGREEMENT  
WITH THE CITY OF HIALEAH; PROVIDING FOR  
INCORPORATION OF RECITALS; PROVIDING FOR  
AN EFFECTIVE DATE. (PIDERMANN)**

**WHEREAS**, on July 8<sup>th</sup> 2014, Town of Miami Lakes (the “Town”) Council passed a resolution authorizing an interlocal agreement between the City of Hialeah (the “City”) and Town of Miami Lakes regarding the storage and maintenance of the Town’s Transit Buses, which was agreed to by the City of Hialeah on March 31, 2015; and

**WHEREAS**, on March 16, 2018, the Town remitted its request for a two-year extension of the interlocal agreement that was accepted by the City, on April 2, 2018 (a true and correct copy of the March 31, 2015 interlocal agreement and April 2, 2018 extension are attached hereto as composite Exhibit “A.”); and

**WHEREAS**, said agreement lapsed on of about April 2, 2020; and

**WHEREAS**, the Town and City of Hialeah have continued to honor the agreement on a month-to-month basis; and

**WHEREAS**, the Town desires to execute a retro-active agreement, memorializing the current agreement in place with the City.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE  
TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

**Section 2. Memorializing a Retroactive Agreement with the City of Hialeah, for the Storage of Circulator Buses.** The Town Council approves a retroactive agreement with the City of Hialeah, extending the terms of the agreement entered on March 31, 2015, for the storage of Town Circulator Buses from March 31, 2020 through March 31, 2024.

**Section 3. Authorization of Town Officials.** The Town Manager and/or his designee are authorized to expend budgeted funds.


**Section 4. Effective Date.** This Resolution shall be effective immediately upon adoption.


