

As you will see throughout this report, Miami Lakes is in excellent financial and operational condition, and has accomplished many achievements over the last year."

Some of the most important accomplishments in FY2018-19 are summarized next.

HIGHLIGHTS



OVERVIEW

The Town of Miami Lakes was incorporated on December 5, 2000. It is one of 34 municipalities in Miami Dade County, Florida. Conveniently located just 16 miles north of Downtown Miami and only 10 miles from Miami International Airport, our Town is home to approximately 30,000 residents and 1,500 businesses. The Town encompasses about 6.5 square miles, bound by NW 170th Street and the Palmetto Expressway (SR 826) to the north, NW 138th Street to the south, NW 57th Avenue (Red Road) to the east, and Interstate 75 to the west.

Small-town feel...

Over the last 60 years, Miami Lakes has evolved from a dream on paper to a vibrant community that has been nationally recognized as one of the best examples of unique and innovative town planning. Although the Town is predominantly low density, an active and popular Town Center, as well as strategically placed large parks, pocket parks, schools, religious and commercial centers throughout the Town, provide a variety of services and social interaction opportunities, creating a community with a small town feel. The housing inventory is also varied, ranging from medium density multifamily to large waterfront single family properties, including lakefront town house communities. The prevalent many nonresidential uses are light industrial and office parks comprising 13% of the Town's area, and lakes and canals making up about 11%; the town businesses employ around 30,000 people, 12% of which reside in Miami Lakes. The population of the Town of Miami Lakes had grown to 30,571 as upcoming 2020 census. It currently ranks 12th in population size within Miami Dade County. Comparable cities include Coral Gables on the high end of the population spectrum and Pinecrest on the lower end.

FORM OF GOVERNMENT

The Town Council is vested with all legislative powers of the Town. The Council consists of the Mayor and six residential Councilmembers. As defined in the Town's Charter, the Mayor shall preside at meetings of the Council and be a voting member of the Council & is elected at-large for a four-year term.



The Town of Miami Lakes has adopted, through the Charter, a "Council-Manager" form of government.

Pursuant to the Town Charter, the Council legislative duties include the following:

Adopt or amend an administrative regulation or establish, alter or abolish any Town office, department, board or agency

Establish a rule or regulation, the violation of which carries a penalty

Levy taxes or appropriate funds

Set services or user charges for municipal services or grant administrative authority to set such charges

Authorize the borrowing of money

Convey or lease or authorize by administrative action the conveyance or lease of any lands of the Town

Mend or repeal any ordinance previously adopted

Grants:

The Grants Office secured over **\$2.187 million** in FY2019 (totaling more than \$12.2 million over the last three fiscal years).

ADMINISTRATION

Technology and Innovation (SP2I Office)

The Technology and Innovation Office is responsible for providing leadership, coordination, and management of the Town-wide strategic initiatives, programs and projects. The SP2I Office focuses on both the Town's long-term future and pressing technology needs such as cybersecurity, ADA digital compliance, citizen relationship management, and other topics aimed to improve the effectiveness and efficiency of processes and services.

Highlights:

- Developed a state-of-the-art GIS-based portal, "Imagine Miami lakes 2025", to showcase the Town's projects and strategic priority plans in one centralized location (the site has received more than 10,000 views and it was highlighted by the MDC Office of Resilience newsletter in 2019).
- Improved the Town's data backup, anti-spam, antiphishing, and anti-virus capacity and protection. Kicked-off **Cybersecurity** 101 Training (100% employee participation).
- Deployed an enhanced Citizen Relationship Management (CRM) platform: **MiamiLakesConnect**. The new platform is the fastest and easiest way for residents to submit requests to the Town.
- Successfully participated and collaborated with the City of Miami on a cross-functional and multijurisdictional training program to solve problems or identify opportunities of improvement. An application of such techniques, resulted in **direct savings** of \$6K/year for the Town by converting analog fax lines into eFax (digital fax lines) which offer higher quality and additional features at better cost.



ADMINISTRATION

Office of the Clerk

- Deployed live public comments (one of the first municipalities in the nation to offer this feature). Citizens are able to interface with a real live audience and participate on Town Hall Meetings from the comfort of their home or preferred place with an Internet connection.
- Moving forward in FY2019, all workshops, in addition to Special Calls Meetings, Planning & Zoning and Regular Council Meetings are livestreamed (including a live-closed caption component).



FINANCIAL HIGHLIGHTS

The Town of Miami Lakes is in excellent financial condition. The Town's conservative financial management approach has allowed our municipality to maintain an AA+ Fitch rating and an Aa2 moody rating. The Finance Department has embraced technology in enhancing government transparency by providing more frequent key financial data on the Town's website, including monthly check registers and budget-to-actual reports. In addition, to further accelerate and advance our long term transparency vision through the data sharing and analytical capabilities, a Tyler Technologies cloud based transparency module is scheduled to be released in FY2020 (maximizing the full potential of our installed Tyler/MUNIS product solutions).

The Town of Miami Lakes' uses independent contractors to consecutively maintain one of the lowest millage rates in the County, without sacrificing levels of services. The Town's low tax rate (2.3127) ranks 6th lowest when compared to all municipalities in Miami-Dade County in the millage rate they impose on property values (which is the main source of funding for local governments.) The town received the "Excellence in Financial Reporting Award" from the Government Financial Officers Association (GFOA).

The Finance Department records and reports the financial transactions of the Town in accordance with Generally Accepted Accounting Principles applicable to governmental entities. This includes activities such as the preparation of financial statements and other reports, cash management, revenue collection, disbursements, payroll, audit coordination and risk management, as well as providing assistance with the preparation and monitoring of the annual budget.



FINANCIAL HIGHLIGHTS

The Town's Finance Department provides support on financial and fiscal matters and strives toward the accomplishment of its goals which include the following:

- Maintain proper accountability over the Town's financial resources
- Prepare accurate and timely financial reports on the Town's financial condition
- Ensure proper implementation of financial and accounting practices for the effective and efficient use of the Town's financial resources

ACCOMPLISHMENTS

- Successfully completed our FY17 18 audit without findings, which led to the Certificate of Achievement for Excellence in Financial Reporting
- Maintained AA+ Fitch Rating and Aa2 Moody Rating
- Completed all reporting to FEMA related to hurricane Irma. FEMA obligated 100% of our \$4.6 million claim.
- Investment FY2019 yielded \$244,000 in interest income

BUILDING DEPARTMENT

The Building Department provides customer-friendly services including review, processing, issuance and inspection of building permits and assurance that construction in the Town complies with the provisions of all applicable codes. The Building Department has continued to work on enhancing services overall to better serve the residents and businesses of the Town of Miami Lakes.

COMMUNICATION AND TRANSPARENCY



The Department of Communications and Community Affairs directs and supports the Town's communications efforts to Miami Lakes residents through proactive and responsive activities, including media relations, publications, special events, and website content management.

Examples of these measures include:

Communications:

- *Expanded Social Media Presence*: Social media is one of the tools used to support the Town's communication efforts. The Town of Miami Lakes has multiple social media accounts to help inform and engage residents including Twitter, Instagram, and Facebook which are the most commonly used social media platforms.
- To further enhance community engagement, the Town is also using other social media tools such as NextDoor, YouTube, and LinkedIn, . The Town now benefits from Verified Status on Facebook and Instagram with 7,987 and 9,346 followers respectively, Twitter currently has 3,230 followers.

COMMUNICATION AND

- *Monthly eNewsletter*: In order to expand our digital reach outside of social media, the Town publishes a monthly online newsletter with an audience of 8,000 subscribers and a 30% average click through rate. The eNewsletter was first published in May 2017.
- *Media Relations:* The Town of Miami Lakes submits an average of 30 press releases to the Miami Laker in order to reach residents and businesses that are not digitally active. The Miami Laker is circulated to 16,000 homes and almost 200 businesses.
- Live and Recorded Videos: Over 50 videos have been produced to announce breaking news and promote community events with a very good response from the online community.

In summary, social media following and engagement has grown by 107% in FY2019, reaching 8.3 million impressions in just the last quarter.

COMMUNICATION AND

Citizen Response:

- *MiamiLakesConnect.com* (and mobile App) allows citizens to immediately report service requests via a mobile app or web portal. The Town received over 1,300 service requests from October 2018 September 2019.
- Facebook Messenger and Instagram Direct Messenger have become an additional method to engage with citizens. In FY 2018-19 the Communications Department has responded to over 300 messages on Facebook Messenger and 400 on Instagram Direct Messenger.

Website:

The mobile friendly I Heart Miami Lakes website www.iheartmiamilakes.com has seen an 87% increase in visitors. Having a mobile friendly website is a critical part of the online experience as smart phones and tablet devices are exceeding desktop traffic. The Town of Miami Lakes is committed to facilitating the accessibility and usability of its website www.miamilakesfl.gov for people with disabilities.

Committees and Special Events:

The Communications and Community Affairs Department provides support to the ten council-appointed volunteer committees and boards. Through these committees and boards, the Town hosts over one-hundred and fifty (150) special events per year with a total of about 41,000 attendees. Local businesses have the opportunity to position themselves in front of Town residents by way of sponsorship to events and programs. This past year the Town received over \$90,000 in sponsorship dollars (paid and in-kind donations).



ECONOMIC DEVELOPMENT

The Town's current and long-term planning efforts are primarily focused on economic development and redevelopment.

To assist and promote the continued viability and occupancy of the Town's commercial and industrial areas the Town's Administration, Planning, Zoning, Building and Economic Development staff coordinate regularly with local realtors, business owners, developers and property owners to assist in the streamlining of regulatory processes to remove barriers impediments to quality development or or redevelopment in accordance with the Town's requirements. These types of activities are essential to encourage and assist new business owners and perspective developers to choose Miami Lakes as their home.




ECONOMIC DEVELOPMENT

Highlights

- Hosted over 150 events, including the inaugural Sponsorship Appreciation Breakfast.
- Hosted the first ever Culinary Bike Tour, a collaboration between the Cultural affairs, Economic Development and the Neighborhood Improvement Committees together with the Miami Dade County Bike305 Initiative. Almost 200 attendees enjoyed samples from different restaurants and cafes in town.
- Mayor and Town Council welcomed over 20 new businesses with a ribbon cutting ceremony and live-streaming on the Town's Facebook page.
- Awarded Best of Miami Lakes Business Award supporting Small Business Saturday to over 20 local businesses.

PARKS AND RECREATION

Tree City USA GROWTH AWARD For 10 straight years

Grant Award **NEAT STREET** Miami-Dade County

The Town of Miami Lakes is only the 3rd Sterling Tree City recognized in Miami –Dade County and the 26th in the State of Florida.

The Parks and Recreation department oversees the operation and maintenance of the Town's 101 parks, rights of way, median green spaces, six lakefront beaches and its urban tree canopy. The parks are open seven days a week and feature a variety of amenities for residents of every age and lifestyle including: lighted sports fields, basketball courts, tennis courts, jogging trails, exercise stations, tot lots, shaded playgrounds, passive areas and covered pavilions/picnic tables.




PARKS AND RECREATION: HIGHLIGHTS

- Recipient of the Neat Streets Grant Award from Miami-Dade County which assisted in funding the West Lakes Reforestation Project Phase 3 creating beautiful green corridors with the installation of 114 shade trees.
- Recipient of the Tree City USA award for 12th consecutive year and recipient of the Tree City USA Growth Award for 10 straight years. This now makes Town of Miami Lakes a "Sterling City" which is awarded by the Arbor Day Foundation recognizing communities for their higher levels of tree care, highlighting innovative programs and projects as well as increased commitment of resources for urban forestry (Miami Lakes is only the 3rd "Sterling City" in Miami-Dade County and 26th "Sterling City" in the State).
- Added 222 new shade trees to the Town's Tree Canopy
- Installation of New Park Benches and Receptacles in 25 pocket parks around Town (Phase 1) and, installation of New Park Rule Signs at 28 pocket parks around Town (Phase 2)



PARKS AND RECREATION: HIGHLIGHTS

- Completed redevelopment of the vacant parcel in the SW corner at Royal Oaks Park for passive community use named in honor of Breanna Vergara (Bre's Courtyard)
- Partnership with the Health Council of South Florida adding community discussions on issues for older adults
- Completion of the LED sports field lighting retrofit project at Royal Oaks Park with 90% funding coming from a State Grant
- Completion of the Picnic Park West playground improvement project: adding 2 new Expression swings, new shade structures over swing area, resurfacing playground safety surface, 5 new benches, and a Free Little Library
- Commencement of the 154 Linear Bridge Park-Phase 1 Design



PARKS AND RECREATION: HIGHLIGHTS

- Named a Certified City in the BETTER CITIES FOR PETS[™] program. The BETTER CITIES FOR PETS[™] program helps cities be pet-friendly so more people can enjoy the benefits of a life with pets. It was created by Mars Petcare and includes a playbook for cities, an assessment tool, a city certification program, and free online resources.
- Recipient of the Miami-Dade Age-Friendly 2019 Mini Grant for installation of an ADA access door at Mary Collins Community Center
- Introduced 5 new pilot youth programs and 2 new pilot adult programs with participation increasing by approximately 160 attendees
- EKG screenings administered to 157 youth athletic participants through the Miami Lakes Optimist Club and Nicklaus Children's Hospital. To date, 5 EKG screenings have come back abnormal potentially saving these lives from sudden cardiac arrest or other related issues
- Approximately 400 participants for one season of Flag football placing this program as one of the top in South Florida. Three (3) teams from the Travel program placed top 3 in their age division at the Flag Football Summer National Tournament in Canton, Ohio

PLANNING DEPARTMENT





Planning is responsible for preparing plans and regulatory tools to provide for the growth and enhancement of Miami Lakes, as well as updating, gathering, and analyzing demographic, environmental, transportation, and infrastructure data needed by other Town departments. both Planning processes administrative and public hearing zoning applications, including rezoning, conditional uses, variances, site plans, and plats. Finally, the department is responsible for maintaining the Town's geographic information system (GIS).

Workshops and Ordinances:

- Amending the Land Development Code to provide regulatory support to the Town's "Beautification Master Plan" and "Tree Management Plan"
- Amending Land Development Code to reduce Variance Fees for single family and Townhome applicants
- Amending the Land Development Code to allow corner properties on RU-1Z Districts to have a patio slab within a required street side yard

PLANNING DEPARTMENT



Workshops and Ordinances:

- Amending Land Development Code (LDC) regarding parking of Commercial vehicles in Town's rights-of-way
- Amending the LDC to exclude hemp derived products and commercial and industrial activities related to hemp derived products from the objective of the Town's ban of cannabis dispensaries, medical marijuana treatment facilities and testing laboratories
- Amending LDC to adequately provide for community homes in residential districts
- Amending the LDC to allow for Standing Metal Seam roofs on Single Family Districts
- Amending the LDC requiring that specific business uses within the town boundaries post Human trafficking public awareness signs in full view of employees
- Workshops, Ordinances and Resolutions necessary in order for the Town to achieve Solsmart Bronze Designation and prepare the way for Gold Designation
- Assisted federal agencies with data preparation for 2020 Census



The Town of Miami Lakes Police services are delivered by the Miami Dade Police Department via an Inter local Agreement. The Town contract is contingent of 49 Police personnel. The Town continues to be one of the safest places to live in the State, having an average response time of 6.5 minutes.



PUBLIC SAFETY: FIRE

MDFR is considered one of the most elite Fire Rescue departments in the country and is recognized around the world for its exemplary service.

During calendar years 2019 and 2018, MDFR responded to 6,726 emergency calls received from the Town of Miami Lakes.

PUBLIC WORKS DEPARTMENT

The Public Works Department provides safe, reliable, and effective services to residents, employees, businesses, and visitors of the Town. The Department is responsible for the operations, maintenance, and improvements of the Towns infrastructure. This includes canal cleaning, street sweeping, litter debris pick up, signs repairs and replacement, sidewalk repairs, roadway repairs, storm drainage system maintenance and repair, street lights, capital improvement projects, and facility maintenance. As part of its Stormwater Master Plan, the Town of Miami Lakes is undertaking a series of drainage improvement projects to protect surface water quality and reduce flooding within the Town.


TRANSPORTATION





In FY 2018 the Town switched to On-Demand transportation providers and contracted with Freebee to provide the service. The new service has allowed the Town to enhance the previous on-demand service by operating two 5 passenger vehicles and one 10 passenger van with ADA accessibility providing more flexibility to our riders.

In FY 2019 the Town was able to provide 23,306 rides and saw an **increase in on-demand ridership by 140%** compared to last year. The Freebee program has been able to reduce the number of vehicles on the road minimizing gridlock, link the Town's public transportation systems, and provide a convenient way for people to travel around Town.
