

RESOLUTION NO. 23-1900

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING A WORK ORDER, PURSUANT TO CONTRACT 2021-43 FOR CIVIL ENGINEERING AND RELATED SERVICES, WITH MARLIN ENGINEERING, INC. FOR THE MIAMI LAKES FAIRWAY DRIVE BIKE LANES AND CROSSWALKS IMPROVEMENTS PROJECT; PROVIDING FOR AUTHORITY OF TOWN OFFICIALS; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR ROUNDING; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, during the November 9, 2021 Town of Miami Lakes (the “Town”) Council meeting, the Town Council awarded Contract 2021-43 to Marlin Engineering, Inc., for Civil Engineering and Related Services; and

WHEREAS, the Town’s Strategic Transportation Plan identifies road infrastructure improvements throughout the Town, including paved bike trails; and

WHEREAS, included in the Town’s Strategic Transportation Plan are paved bike lanes through Fairway Drive, allowing bicyclist to travel from Miami Lakes Drive to Miami Lakeway North; and

WHEREAS, Town Staff and Marlin Engineering, Inc. (“Marlin”) have negotiated the scope of work and fee for design services for Miami Lakes Fairway Drive Bike Lanes and Crosswalks Improvements, Work Order No. 2, for an amount not to exceed, One Hundred Thirty Five Thousand One Hundred and Two Dollars and 45/100 (\$135,102.45); and

WHEREAS, it is recommended that the Town Council approve Work Order No. 2 with Marlin Engineering, Inc. for Miami Lakes Fairway Drive Bike Lanes and Crosswalks Improvements, Work Order No. 2.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. **Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. **Approval of the Work Order** The Town Council approves Work Order No. 2, with Marlin Engineering, Inc., for Miami Lakes Fairway Drive Bike Lanes and Crosswalks Improvements Project in an amount not to exceed, One Hundred Thirty Five Thousand One Hundred and Two Dollars and 45/100 (\$135,102.45), as described in Exhibit “A.”

Section 3. **Authorization of Town Officials.** The Town Manager and/or his designee and the Town Attorney and/or his designee are authorized to take all steps necessary to implement Work Order No. 2, with Marlin Engineering, Inc. as described in Exhibit “A.”

Section 4. **Authorization of Fund Expenditure.** The Town Manager is authorized to expend budgeted funds for Work Order No. 2, with Marlin Engineering, Inc., as described in as described in Exhibit “A,” in amounts not to exceed One Hundred Thirty Five Thousand One Hundred and Two Dollars and 45/100 (\$135,102.45).

Section 5. **Effective Date.** This Resolution shall take effect immediately upon adoption.




