

**RESOLUTION NO. 23-1913**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO AUTHORIZE THE TOWN MANAGER TO EXECUTE AND INTERLOCAL AGREEMENT BETWEEN THE TOWN OF MIAMI LAKES AND MIAMI-DADE COUNTY; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE. (GONZALEZ)**

**WHEREAS**, Miami-Dade County provides the Town of Miami Lakes (the “Town”) with a Police Force in order for the Town to carry out its municipal police functions; and

**WHEREAS**, in addition to the Town Code and Florida Statute, the Town’s police department may enforce various Miami-Dade County codes; and

**WHEREAS**, in order for the Town’s police department to enforce provisions of the Miami-Dade County Code, an interlocal agreement is necessary to be executed between the Town and Miami-Dade County; and

**WHEREAS**, the interlocal agreement between Miami-Dade County and the Town, attached hereto as Exhibit “A” will allow the Town’s police department to enforce provisions of Miami-Dade County code that provide greater protection to our Town residents and are in the best interest of our Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

**Section 2. Approval of Interlocal Agreement between Miami-Dade County and Town of Miami Lakes.** The Town Council hereby approves the Interlocal Agreement between Miami-Dade County and the Town of Miami Lakes for enforcement of Miami-Dade County Ordinances attached hereto as Exhibit “A.”

**Section 3. Authorization of Town Manager.** The Town Manager and/or his designee is authorized to execute the interlocal agreement between Miami-Dade County and the Town of Miami Lakes for enforcement of Miami-Dade County Ordinances in substantially the same form as attached hereto as Exhibit “A,” and if necessary, sign any extensions, modifications or amendments as necessary.

**Section 4. Authorization of Town Officials.** The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the interlocal agreement between Miami-Dade County and the Town of Miami Lakes for enforcement of Miami-Dade County Ordinances. The Town Clerk is hereby directed to send copies of this Resolution to any person or agency as directed by the Council of the Town of Miami Lakes.

**Section 5. Effective Date.** This Resolution shall take effect immediately upon adoption.


