

RESOLUTION NO. 23-1938

A RESOLUTION OF THE TOWN OF MIAMI LAKES, FLORIDA, PURSUANT TO TOWN CODE ARTICLE XII, DIVISION 2, NAMING 59th AVENUE, FRED SENRA WAY; PROVIDING FOR INSTRUCTIONS TO TOWN MANAGER; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE. (TOWN COUNCIL)

WHEREAS, during the June 2023 Town of Miami Lakes (the “Town”) Council Meeting, the Town Council approved the dedication of 59th Avenue in honor of Mr. Fred Senra; and

WHEREAS, Mr. Fred Senra a Town resident and business owner, has provided of time, talent and treasure to benefit all Town residents; and

WHEREAS, of significance, Mr. Fred Senra’s generosity has provided for the Memorial Day, Veterans Banners, assisted with the Town’s Food and Wine Festival, has reorganized, and revived the Town’s Chamber of Commerce, and has provided countless hours to the Town’s Foundation; and

WHEREAS, Article XII, Division 2 of the Town Code, provides the exclusive method by which Town facilities can be dedicated and named; and

WHEREAS, pursuant to Article XII, Division 2 of the Town Code, on May 9, 2023, a public hearing regarding the naming of 59th avenue in honor of Mr. Fred Senra was held; and

WHEREAS, pursuant to Article XII, Division 2 of the Town Code, on July 28, 2023, this Resolution was published in the Daily Business Review; and

WHEREAS, after hearing testimony provided by Staff and the Public, the Town Council finds that 59th Avenue should be named in honor of Mr. Fred Senra.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. **Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. **Dedication of N.W. 59th Avenue in Honor of Mr. Fred Senra.** Pursuant to the Town Code, the Town Council hereby adopts this resolution and instructs staff to properly dedicate N.W. 59th Avenue in honor of Mr. Fred Senra

Section 3. **Authorization of Town Officials.** The Town Manager and/or his designee are authorized to expend budgeted funds to create the necessary signage to achieve Section 2 of this Resolution.

Section 4 **Effective Date.** This Resolution shall be effective immediately upon adoption.
