

RESOLUTION NO. 23-1951

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE AWARD OF CONTRACTS FOR ITB 2023-36R, TO STONE CONCEPT MIAMI, INC. AND FLORIDA SIDEWALK SOLUTIONS FOR REPAIR OF SIDEWALK TRIP HAZARDS IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 2, Article V, Division 2, Section 2-155 of the Town Code provides that procurements more than \$15,000 shall require the use of competitive sealed bidding; and

WHEREAS, in accordance with Chapter 2, Article V, Division 2, Section 2-155 of the Town Code, the Town issued Invitation to Bid (“ITB”) No. 2023-36R for Repair of Sidewalk Trip Hazards (the “Services”); and

WHEREAS, the ITB was advertised online via two public bidding websites, DemandStar and Public Purchase, and was physically posted in the Government Center Lobby; and

WHEREAS, the Town received five (5) bids from the following:

- 1) Stone Concept Miami, Inc.
- 2) Florida Sidewalk Solutions

WHEREAS, based on due diligence, Procurement determined that Stone Concept Miami, Inc., and Florida Sidewalk Solutions were the lowest responsive and responsible bidders; and

WHEREAS, Procurement recommends awarding contracts to Stone Concept Miami, Inc. and Florida Sidewalk Solutions in an amount not to exceed budgeted funds; and

WHEREAS, the Town Manager concurs with Procurement's recommendation and recommends the Town Council authorize the award of contracts to Stone Concept Miami, Inc. and Florida Sidewalk Solutions for Repair of Sidewalk Trip Hazards in an amount not to exceed budgeted funds; and

WHEREAS, the Town Council approves the recommendations of the Town Manager and authorizes the Town Manager to enter into contracts with Stone Concept Miami, Inc. and Florida Sidewalk Solutions for Repair of Sidewalk Trip Hazards.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the award of contracts to Stone Concept Miami, Inc., and Florida Sidewalk Solutions for Repair of Sidewalk Trip Hazards in an amount not to exceed budgeted funds, in substantially the same form as attached hereto as Exhibit "A" (hereinafter referred to as "Contract").

Section 3. Authorization of Fund Expenditure. The Town Manager, his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract.

Section 4. Authorization of Town Officials. The Town Manager and/or his designee and the Town Attorney and/or his designee are authorized to take all steps necessary to

finalize and carry out the terms of the agreements with Stone Concept Miami, Inc., and Florida Sidewalk Solutions.

Section 5. **Execution of the Contract.** The Town Manager is authorized to execute the Contracts with Stone Concept Miami, Inc. and Florida Sidewalk Solutions for Repair of Sidewalk Trip Hazards in an amount not to exceed budgeted funds and to execute any extension and/or amendments to the Contract, subject to approval as to form and legality by the Town Attorney.


Section 6. **Effective Date.** This Resolution shall take effect immediately upon adoption.


