RESOLUTION NO. 14-1178

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA; ACCEPTING A REQUEST FROM MICHELLE LEON TO REDUCE PREVIOUSLY ASSESSED CODE COMPLIANCE FINE FOR CASE NO. C2010-0709; DIRECTING THE TOWN MANAGER TO EXECUTE ANY REQUIRED DOCUMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes ("Town"), through its Code Compliance Department, issued Citation No. C2010-0709 ("Citation") to Khosrow Dashtaki ("Previous Owner"); and

WHEREAS, the Citation was issued and the violation was subsequently corrected by Michelle Leon (ex-spouse of Khosrow Dashtaki); and

WHEREAS, the Owner (Michelle Leon aka Michelle Dashtaki) has incurred a total fine and costs of \$7,535.35; and

WHEREAS, the Current Owner has requested that the Town reduce the fines and the Town Manager having reviewed the file has recommended to the Town Council approval of a reduction of the fines and costs from \$7,535.35 to \$538.19 (which is equal to one days' fine and the costs incurred by the Town to process the case); and

WHEREAS, the Current Owner has agreed to sign a release of the Town from any claims relating to the Citation as a condition of the reduction.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1</u>. <u>Recitals.</u> The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Reduction of Fine. The civil penalties/fines for Code Compliance

Case No. C2010-0709 is reduced to \$538.19 subject to the Current Owner paying the

reduced amount no later than 60 days from the effective date of this Resolution. The Town Manager is authorized to execute appropriate documents, including a release and waiver by the Current Owner for any and all claims relating to the Citation and this reduction.

Section 3. Conditions. In the event the reduced fine is not paid within sixty (60) days of the effective date of this Resolution, the original fine amount shall be reinstated and continue to accrue interest as if this Resolution had not existed.

Section 4. Effective Date. This Resolution shall be effective immediately upon adoption.
