

RESOLUTION NO. 14-1183

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO APPROVE THE PURCHASE OF FIVE (5) FORD INTERCEPTOR VEHICLES FOR POLICE DEPARTMENT USE, IN AN AMOUNT NOT TO EXCEED \$114,545.00; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO UTILIZE THE FLORIDA SHERIFFS' ASSOCIATION CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Town of Miami Lakes ("Town") desires to purchase five (5) 2014 Ford Interceptor vehicles for Police Department use; and

WHEREAS, the Town intends to purchase five (5) Ford Interceptor vehicles from the Florida Sheriff's Association contract which is the primary contract for the purchase of fleet vehicles by public entities statewide; and

WHEREAS, the necessary funding of \$114,545 is available from the FY 21013-2014 Police Capital Outlay fund; and

WHEREAS, the best source for the purchase of the five (5) Ford Interceptor vehicles is from Don Reid Ford Inc., under contract with the Florida Sheriffs' Association, which is being piggybacked on for this purchase.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above Recitals are true and correct and incorporated herein by reference.

Section 2. Authorization of Town Manager. The Town Council hereby approves and authorizes the Town Manager to purchase five (5) Ford Interceptor vehicles for Police Department use from Don Reid Ford, Inc., in an amount not to exceed \$114,545, which is available from the FY 2013-2014 Police Capital Outlay fund.

Section 3. Execution of the Contract. The Town Manager is authorized to utilize the Florida Sheriffs' Association contract on behalf of the Town for the purchase of five (5) Ford Interceptor vehicles.

Section 4. Authorization of Town Manager. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions for the purchase of the vehicles.

Section 5. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Contracts.


Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.




