

**RESOLUTION NO. 14-1207**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA URGING THE MIAMI-DADE COUNTY PROPERTY APPRAISER TO OPEN A BRANCH OFFICE OF THE OFFICE OF THE MIAMI-DADE COUNTY PROPERTY APPRAISER IN THE TOWN OF MIAMI LAKES; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town Council for the Town of Miami Lakes wishes to provide the citizens of the Town with greater access to Miami-Dade County services; and

**WHEREAS**, the Town Council for the Town of Miami Lakes desires that a branch office of the Office of the Miami-Dade County Property Appraiser be opened within the Town of Miami Lakes; and

**WHEREAS**, it is within the discretion of the Miami-Dade County Property Appraiser to open a branch office;

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing recitals are true and correct and are incorporated herein by reference.

**Section 2. Request to Miami-Dade County Property Appraiser.** The Miami-Dade County Property Appraiser is requested to consider opening a branch office of the Office of the Miami-Dade County Property Appraiser within the Town of Miami Lakes.

**Section 3. Direction to Clerk.** The Town Clerk is directed to send a certified copy of this resolution to the Miami-Dade County Property Appraiser, Lazaro Solis, C.F.A., to consider opening a branch office of the Office of the Miami-Dade County Property Appraiser within the Town of Miami Lakes.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon adoption.
