RESOLUTION NO. 15- 1284

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA URGING THE MIAMI-DADE EXPRESSWAY AUTHORITY ("MDX") TO PROVIDE A DISCOUNT TO MIAMI LAKES RESIDENTS ON TOLL ROADS OPERATED BY MDX; PROVIDING AUTHORIZATION TO TOWN OFFICIALS; PROVIDING DIRECTIONS TO TOWN CLERK; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Miami-Dade Expressway Authority ("MDX") operates toll roads throughout Miami-Dade County; and

WHEREAS, MDX has recently afforded a discount on tolls to five-axle trucks; and

WHEREAS, the Town Council of the Town of Miami Lakes ("the Town") would like for MDX to grant the same discount afforded to five-axle trucks on tolls to Town of Miami Lakes residents, specifically to those residents who have toll transponders or license plates registered to a Miami Lakes address.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL FOR THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1. Recitals.</u> The foregoing recitals are true and correct and are incorporated herein by reference.

<u>Section 2. Request to MDX.</u> The Town Council hereby requests that the Miami-Dade Expressway Authority grant the same discount afforded to five-axle trucks on tolls to Town of Miami Lakes residents, specifically to those residents who have toll transponders or license plates registered to a Miami Lakes address.

<u>Section 3. Authorization of Town Officials.</u> The Town Manager and/or his designee and the Town Attorney are authorized to take all actions necessary to implement this Resolution.

<u>Section 4. Directions to Town Clerk.</u> The Town Clerk is directed to send a certified copy of this Resolution to the Executive Director of the Miami-Dade Expressway Authority within ten (10) days of this Resolution being adopted.

Section 5. Effective Date. This Resolution shall be effective immediately upon adoption.
