## **RESOLUTION NO. 15-1311**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA CODESIGNATING LOCH NESS DRIVE AS **SERGIO CAMPOS WAY:** AUTHORIZING TOWN OFFICIALS TO TAKE ALL STEPS **NECESSARY** TO **CODESIGNATE** THE STREET: **AUTHORIZING TOWN** MANAGER TO ERECT APPROPRIATE MARKERS; PROVIDING DIRECTIONS **TOWN** CLERK; AND **PROVIDING** FOR AN EFFECTIVE DATE.

WHEREAS, Sergio Campos and his wife Miriam moved to Miami Lakes nearly thirty years ago; and

WHEREAS, throughout his life, Sergio Campos dedicated his time and effort to several community service activities; and

WHEREAS, Sergio Campos served as Director of the Lions Home for the Blind – Miami; President of the Miami Cuban Lions' Club; Chairman of Public Relations for the Lions Clubs of South Florida; and President of the Cuban Lyceum; and

WHEREAS, Sergio Campos also served as President of the Loch Ness Homeowners' Association for approximately twenty years; and

WHEREAS, Sergio Campos' focus as President of the Loch Ness Homeowners' Association was on the greenery along the banks of the lake, the quality of the lake water, the safety of the neighborhood playground, and the entrance and egress to the Loch Ness neighborhood to and from Northwest 67<sup>th</sup> Avenue; and

WHEREAS, Sergio Campos passed away on April 26, 2015; and

WHEREAS, in recognition of Sergio Campos' many years of service to the Town of Miami Lakes and its residents, the Town Council for the Town of Miami Lakes ("the Town") desires to co-designate Loch Ness Drive as "Sergio Campos Way" to recognize the contributions of Sergio Campos to the community; and

WHEREAS, there appears to be no roadway in the Town with this name or any similar sounding name; and

WHEREAS, is it necessary for identification purposes to confirm the name of this roadway; and

WHEREAS, pursuant to Section 2-1, Rule 9.02 of the Town Code (Miami-Dade County Code as made applicable to the Town pursuant to the Town Charter), the Town Council has held a public hearing to consider the co-designation of the roadway;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL FOR THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing recitals are true and correct and are incorporated herein by reference.

Section 2. Designation. The Town Council hereby co-designates that Loch Ness Drive as "Sergio Campos Way."

<u>Section 3.</u> <u>Authorization of Town Officials.</u> The Town Manager and/or his designee and the Town Attorney are authorized to take all actions necessary to implement this Resolution. The Town Manager and/or his designee is directed to erect appropriate markers recognizing the co-designation of Loch Ness Drive as "Sergio Campos Way."

<u>Section 4.</u> <u>Directions to Clerk.</u> The Town Clerk is directed to send a certified copy of this resolution to the United States Postal Service in order to verify the street designation for postal records.

Section 5. Effective Date. This Resolution shall be effective immediately upon adoption.
