RESOLUTION NO. 15-1307

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, MODIFYING THE ROUTE OF THE MIAMI LAKES MOOVER CIRCULATOR SYSTEM; PROVIDING DIRECTIONS TO THE TOWN CLERK; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes, Florida ("the Town") operates a free, fixed route circulator transit service known as the Miami Lakes Moover; and

WHEREAS, the Miami Lakes Moover service currently consists of one route known as the Miami Lakes Moover Route, with two buses operating the route from 6:00 AM to 10:00 AM and 2:15 PM to 7:00 PM on weekdays; and

WHEREAS, the Town has undertaken an analysis to evaluate and improve the route, taking into account rider feedback and demand concerning the lack of viable connections to Miami Lakes Buses traveling west from the Lake Patricia, Lake Hilda and Lake Martha neighborhoods as well as transportation options for Miami Lakes Residents attending Hialeah-Miami Lakes Senior High; and

WHEREAS, the Town Council finds that modifying the Miami Lakes Moover route, so that as the bus is traveling west it uses Miami Lakes Drive instead of Fairway Drive (as shown in Exhibit A attached hereto), will result in a more centralized route which will meet the demand for more expeditious travel west by residents of the Lake Patricia, Lake Hilda and Lake Martha neighborhoods.

WHEREAS, the Town Council finds that modifying the Miami Lakes Moover route so that bus service extends south on NW 67th Avenue to reach Hialeah-Miami Lakes Senior High for two forty-five minute periods daily between the hours of 6:45 AM -7:30 AM and 2:30 PM and 3:15 PM to correspond with school entry and dismissal times (as shown in Exhibit A attached hereto) will allow residents of Miami Lakes to commute more efficiently to school or work at Hialeah-Miami Lakes Senior High.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL FOR THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1. Recitals</u>. The foregoing recitals are true and correct and are incorporated herein by reference.

Section 2. Modification of Route. The route shown on the map attached hereto as Exhibit A is hereby established as the Miami Lakes Moover Route.

Section 3. Authorization of Town Officials. The Town Manager and/ or his designee are authorized to take all steps necessary to implement the intent of this Resolution including, but not limited to, obtaining Miami-Dade County's approval pursuant to the Interlocal Agreement between Miami-Dade County and the Town of Miami Lakes for the Provision of Public Transportation Services.

<u>Section 4. Directions to Clerk.</u> The Town Clerk is directed to serve a certified copy of this Resolution upon the Miami-Dade County Mayor or his designee.

Section 5. Effective Date. This Resolution shall take effect October 5, 2015.


