

RESOLUTION NO. 15-1333

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, ADOPTING THE TOWN'S 2015-2025 STRATEGIC PLAN; AUTHORIZING THE TOWN MANAGER TO TAKE ALL ACTIONS NECESSARY TO IMPLEMENT THE POLICIES AND GOALS UNDER THE STRATEGIC PLAN; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in 2001, the Town of Miami Lakes (the "Town") created its first strategic plan in order to set forth a clear vision for the Town for the following five years; and

WHEREAS, in 2006, via Resolution 2006-415, the Town Council adopted the Town's 2006-2011 Strategic Plan; and

WHEREAS, in January 2014, the Town began its 2015-2025 strategic plan process in order to establish a ten year strategic plan, which included the participation of a great number of Town residents and business leaders through a number of public workshops and meetings ("Strategic Plan"); and

WHEREAS, the goals, priorities and policies outlined in the Strategic Plan reflect the information gleaned from the public workshops, the meetings with Town Staff and Council, and the Town's most recent citizen survey; and

WHEREAS, it is the Town's vision that Miami Lakes be widely recognized as a welcoming community with extraordinary beauty where state of the art planning concepts create vibrant hubs that are safe and friendly to all ages and mobility options which inspire the Town to continue "Growing Beautifully"; and

WHEREAS, it is the Town's mission to make Miami Lakes the model of a friendly, open, innovative, effective and efficient government for its residents and businesses; and

WHEREAS, the Town shall use the 2015-2025 Strategic Plan as a blueprint for the development of major policies, business processes and organizational structure; and

WHEREAS, the Town Council finds that the adoption of the 2015-2025 Strategic Plan is in the best interest of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above-stated recitals are true and correct and incorporated herein by this reference.

Section 2. Adoption of the 2015-2025 Strategic Plan. The Town Council hereby adopts the Town of Miami Lakes 2015-2025 Strategic Plan, attached hereto as Exhibit "A," as a blueprint for continued progress in achieving the Town's vision and mission.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee are authorized to take all actions necessary to implement and promote the policies and goals outlined in the Town of Miami Lakes 2015-2025 Strategic Plan.


Section 4. Effective Date. This Resolution shall take effect immediately upon its adoption.




