RESOLUTION NO. 15-1344

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO APPROVE AWARD OF ITB 2016-15, FABRICATION AND INSTALLATION OF PARK SIGNAGE TO SIGN & GRAPHIC SOLUTIONS, INC. DBA FASTSIGNS OF MIAMI LAKES IN THE AMOUNT OF \$93,357.84 IN ADDITION TO REPLACEMENT SIGNAGE ON AN AS-NEEDED BASIS NOT TO EXCEED BUDGETED FUNDS PER FISCAL YEAR; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE **CONDITIONS TERMS AND OF** THE CONTRACT; **AUTHORIZING THE TOWN MANAGER** TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER **EXECUTE** THE CONTRACT; **PROVIDING** INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town") issued an Invitation to Bid ("ITB") No. 2016-15 on October 27, 2015, for Fabrication and Installation of Park Signage; and

WHEREAS, the Town Manager has determined that Sign & Graphic Solutions, Inc. dba FastSigns of Miami Lakes is the lowest responsive and responsible bidder, and recommends Award of Contract ITB 2016-15 to same; and

WHEREAS, Sign & Graphic Solutions, Inc. dba FastSigns of Miami Lakes, will furnish all labor, materials, machinery, tools, means of transportation, supplies, equipment, and services necessary for final design, fabrication, delivery and installation of new and replacement park signage per bid specifications in accordance with the Town's brand standards; and

WHEREAS, the Town Council approves the recommendations of the Town Manager and authorizes the Town Manager to enter into contract with Sign & Graphic Solutions, Inc. dba FastSigns of Miami Lakes, for Award of Contract ITB 2016-15, Fabrication and Installation of Park Signage, in an amount not to exceed \$93,357.84; and

WHEREAS, the total award amount of \$93,357.84 includes the bid amount of \$83,357.84 and a contingency of \$10,000 to include fabrication and installation of 99 new park entrance and regulation signs as well as any additional or replacement signs as-needed during the term of the contract not to exceed budgeted funds per fiscal year.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the award of ITB 2016-15, to Sign & Graphic Solutions, Inc. dba FastSigns of Miami Lakes, in an amount not to exceed of \$93,357.84 for Fabrication and Installation of Park Signage as well as any additional or replacement signs as-needed during the term of the contract not to exceed budgeted funds per fiscal year.

<u>Section 3. Authorization of Town Officials.</u> The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract with Sign & Graphic Solutions, Inc. dba FastSigns of Miami Lakes for Fabrication and Installation of Park Signage.

<u>Section 4. Authorization of Fund Expenditure.</u> The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of the Contract from the Capital Fund.

Section 5. Execution of the Contract. The Town Manager is authorized to execute the Contract with Sign & Graphic Solutions, Inc. dba FastSigns of Miami Lakes for Fabrication and Installation of Park Signage on behalf of the Town in an amount not to exceed \$93,357.84 as well as any additional or replacement signs as-needed during the term of the contract not to exceed budgeted funds per fiscal year, in substantially the form attached hereto as Exhibit "A."

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
