

RESOLUTION NO. 16-1414

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AWARDED CONTRACT FROM CALL TO ARTIST TO HANS FEYERABEND NOT TO EXCEED \$11,900.00; AUTHORIZING THE TOWN MANAGER TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on November 21, 2015, the Town of Miami Lakes (“Town”) completed construction and hosted a grand-opening of a Youth Center; and

WHEREAS, Miami-Dade County (“County”) Code 2-11.15 requires 1.5% of construction costs of new government buildings to be set aside for public art; and

WHEREAS, to comply with the County’s ordinance, on July 15, 2016, the Town together with the County’s Cultural Affairs Department issued a Call to Artists seeking qualifications of local artists in the Miami-Dade County area; and

WHEREAS, following the recommendation of the County’s Cultural Affairs Department, a Professional Advisory Committee comprised of local professional artists was created to review applications, select the artwork and provide a recommendation; and

WHEREAS, the PAC received and reviewed twenty four submittals, and shortlisted five (5) artists: (1) Cushy Gigs (Melodie Blaize and Alexander Vahan), (2) Janet Mueller, (3) Carlos Inocente Gonzalez, (4) Hans Feyerabend, and (5) Cecilia Lueza (“Short List Artists”) to produce a conceptual rendering of the artwork for the Youth Center; and

WHEREAS, all Short List Artists produced conceptual renderings were reviewed by the PAC, and based on their review Hans Freyerabend’s proposal was selected; and

WHEREAS, Hans Freyerabend will be responsible for the design and construction of the artwork; and

WHEREAS, the Town Manager recommends adoption of the PAC’s recommendation and approval of a contract with Hans Freyerabend for the design and construction of artwork to be installed in the youth center for an amount not to exceed \$11,900.00

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL FOR THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are true and correct and are incorporated herein by reference.

Section 2. Approval of the Contract. The Council approves the award of a contract with Hans Freyerabend for the design and construction of artwork for an amount not to exceed \$11,900.00.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of a contract with Hans Freyerabend for the design and construction of artwork.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds not to exceed \$11,900.00.

Section 5. Execution of the Contract. The Town Manager is authorized to execute, in substantially the form attached hereto as Exhibit "A," contract with Han Freyerabend for the design and construction of artwork, and to execute any required agreements and/or documents to implement the terms and conditions of the contract, subject to approval as to form and legality by the Town Attorney.

Section 6. Effective Date. This Resolution shall be effective immediately upon adoption.






