RESOLUTION NO. 17-1450

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, TO APPROVE AWARD OF CONTRACT FOR RFP 2017-44, DEBRIS MANAGEMENT SERVICES TO ASHBRITT, INC.; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the "Town") issued a Request for Proposals (the "RFP") No. 2017-44 on April 27, 2017, for Debris Management Services; and

WHEREAS, an Evaluation Committee has determined that Ashbritt, Inc. ("Ashbritt") is the lowest responsive and responsible bidder and recommends an Award of Contract 2017-44; and

WHEREAS, Ashbritt will be responsible for furnishing all labor, materials, tools, means of transportation, supplies, equipment and services necessary to complete all the removal and disposal of debris resulting from a disaster event in the Town; and

WHEREAS, the Town Council approves the recommendations of the Evaluation Committee and authorizes the Town Manager to enter into contract with Ashbritt, for Award of Contract 2017-44, for Debris Management Services, for a period of three (3) years with the option to renew the agreement for two (2) additional one year terms, in an amount to be allocated on an as needed basis in response to a disaster event on an as needed basis.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the award of RFP No. 2017-44, to Ashbritt, in an amount to be allocated on an as needed basis for Debris Management Services.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract with Ashbritt for Debris Management Services.

Section 4. Execution of the Contract. The Town Manager is authorized to execute the Contract with Ashbritt for debris management services on behalf of the Town for Debris Management Services, for three (3) years with the option to renew the agreement for two (2) additional one year terms. in the amount to be allocated on an as needed basis, in substantially the form attached hereto.
