RESOLUTION NO. 20-1672

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, URGING GOVERNOR DESANTIS, MIAMI-DADE COUNTY MAYOR GIMENEZ AND MIAMI-DADE COUNTY BOARD OF COUNTY COMMISSIONERS TO ALLOW FOR THE PHASED OPENING OF NON-ESSENTIAL TOWN OF MIAMI-LAKES BUSINESSES; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR INSTRUCTIONS TO THE CLERK; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on March 9, 2020, Florida Governor Ron DeSantis declared a State of Emergency due to the discovery and spread of the COVID-19 virus; and

WHEREAS, COVID-19 has decimated the economy of the State of Florida including, without limitation, the commercial hospitality, service, restaurants, bars, sales, and manufacturing sector and trades; and

WHEREAS, on April 29, 2020, Governor DeSantis promulgated Order 20-112 allowing for the phased re-opening, of many non-essential businesses throughout the State of Florida; and

WHEREAS, due to the number of COVID-19 cases in Miami-Dade, Broward and Palm Beach County, the Governor DeSantis has excluded Miami-Dade, Broward and Palm Beach County; and

WHEREAS, the Town of Miami Lakes has seen very few cases of COVID-19, and has effectively flattened the curve; and

WHEREAS, the Town of Miami Lakes Council believes it is in the best interest of Town residents and business owners to have non-essential businesses to re-open as soon as possible.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL FOR THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are true and correct and are incorporated herein by reference.

<u>Section 2. Request to Governor DeSantis, Miami-Dade County Mayor Gimenez, and</u> <u>Miami-Dade County Board of County Commissioners, to allow the Town of Miami Lakes to</u> <u>re-open non-essential businesses as detailed in Governor DeSantis Executive Order 20-112.</u>

The Town Council respectfully asks Governor DeSantis, Miami-Dade County Mayor Gimenez,

and Miami-Dade County Board of County Commissioners to allow Town of Miami Lakes businesses to re-open as detailed in Governor DeSantis Executive Order 20-112, effective May 4th, 2020.

Section 3. Instructions to the Town Clerk. The Town Clerk is hereby instructed to transmit a copy of this Resolution to Governor DeSantis, Miami-Dade County Mayor Gimenez and the Chair of Miami-Dade County Board of County Commissioners.

Section 4. Effective Date. This Resolution shall be effective immediately upon adoption.
