

RESOLUTION NO. 21-1740

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE AWARD OF CONTRACTS FOR ITB 2021-24, STORM DRAINAGE SYSTEM CLEANING SERVICES TO CLEAN GROUNDS, INC., ENVIROWASTE SERVICES GROUP, INC., AND SHENANDOAH GENERAL CONSTRUCTION IN AMOUNTS NOT TO EXCEED BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in accordance with Chapter 2, Article V, Division 2, Section 2-157 of the Town Code, the Town issued Invitation to Bid (“ITB”) No. 2021-24 on April 2, 2021, for Storm Drainage System Cleaning Services; and

WHEREAS, the ITB was advertised online via two public bidding websites, DemandStar and Public Purchase, and was physically posted in the Government Center Lobby; and

WHEREAS, the Town received ten (10) bids by the proposal deadline, April 23, 2021, from BACO Engineering Contractor, Inc. dba BACO (“BACO”), Clean Grounds, Inc. (“Clean Grounds”), EnviroWaste Services Group, Inc. (“EnviroWaste”), Flotech Environmental, LLC (“Flotech”), IMR Development Corp dba Jennings Pipelining and Services (“Jennings”), National Water Main Cleaning, Co. (“National”), Rogar Management and Consulting of FL, LLC (“Rogar”), Shenandoah General Construction (“Shenandoah”), South Florida Vac-Con Services, Inc. (“Vac-Con”), and Stonehenge Construction, LLC (“Stonehenge”) ; and

WHEREAS, the Town's Procurement Department performed a due diligence review of the bids for responsiveness and did not find any material defects in their qualifications or the bids submitted by Clean Grounds, EnviroWaste, and Shenandoah.

WHEREAS, Procurement recommended awarding contracts to Clean Grounds, EnviroWaste, and Shenandoah to act as the primary, secondary, and tertiary contract, respectively, for storm drainage system cleaning services in amounts not to exceed budgeted funds; and

WHEREAS, the Town Manager concurs with Procurement's recommendation and recommends the Town Council authorize the awards of contracts to Clean Grounds, EnviroWaste, and Shenandoah for storm drainage system cleaning services in amounts not to exceed budgeted funds; and

WHEREAS, the Town Council approves the recommendations of the Town Manager and authorizes the Town Manager to enter into contracts with Clean Grounds, EnviroWaste, and Shenandoah for storm drainage system cleaning services.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. **Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. **Approval of the Contract.** The Town Council hereby approves the award of contracts to Clean Grounds, EnviroWaste, and Shenandoah in substantially the form attached hereto as Exhibit "A" for storm drainage system cleaning services in amounts not to exceed budgeted funds (hereinafter referred to as "Contracts").

Section 3. **Authorization of Town Officials.** The Town Manager, his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contracts.

Section 4. **Authorization of Fund Expenditure.** The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of this Resolution and the Contracts.

Section 5. **Execution of the Contract.** The Town Manager is authorized to execute Contracts with Clean Grounds, EnviroWaste, and Shenandoah for storm drainage system cleaning services in amounts not to exceed budgeted funds and to execute any extension and/or amendments to the Contracts, subject to approval as to form and legality by the Town Attorney.

Section 6. **Effective Date.** This Resolution shall take effect immediately upon adoption.


