RESOLUTION NO. 21-1788

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE AWARD OF A CONTRACT FOR ITB 2021-45, NW 83RD PLACE DRAINAGE **PROJECT** TO IMPROVEMENT RG UNDERGROUND ENGINEERING, INC. IN AN AMOUNT NOT TO EXCEED \$108,141; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING A BUDGET LINE ITEM TRANSFER; AUTHORIZING THE TOWN MANAGER TO **EXPEND** BUDGETED AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; **PROVIDING FOR INCORPORATION** RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Chapter 2, Article V, Division 2, Section 2-157 of the Town Code provides that procurements in excess of \$15,000 shall require the use of competitive sealed bidding; and

WHEREAS, in accordance with Chapter 2, Article V, Division 2, Section 2-157 of the Town Code, the Town issued Invitation to Bid ("ITB") No. 2021-45 on September 16, 2021, NW 83rd Place Drainage Improvement Project; and

WHEREAS, the ITB was advertised on the Miami Daily Business Review as well as online via two public bidding websites, DemandStar and Public Purchase, and was physically posted in the Government Center Lobby; and

WHEREAS, the Town received fourteen (14) proposals by the proposal deadline from RG Underground Engineering, Inc. ("RG"), Acosta Tractors, Inc. ("Acosta"), The Strout Group, LLC ("Stout"), Team Contracting, Inc. ("Team"), GPE Engineering and General Contractor Corp. ("GPE"), Quality Paving, Corp. ("Quality"), National Concrete and Paving, LLC ("National"), ATC Engineering, Inc. ("ATC"), Metro Express, Inc. ("Metro"), Star Paving

Corporation ("Star Paving"), Marcdan, Inc. ("Marcdan"), A.D.A. Engineering, Inc. ("A.D.A."), Pabon Engineering, Inc. ("Pabon"), and Restate Construction, LLC ("Restate"); and

WHEREAS, based on due diligence, Procurement determined that RG was the lowest responsive and responsible bidder; and

WHEREAS, Procurement recommended awarding a contract to RG in an amount not to exceed One Hundred Eight Thousand, One Hundred Forty One Dollars and 00/100 (\$108,141.00); and

WHEREAS, the Town Manager concurs with Procurement's recommendation and recommends the Town Council authorize the award of a contract to RG for the NW 83rd Place Drainage Improvement Project in an amount not to exceed One Hundred Eight Thousand, One Hundred Forty One Dollars and 00/100 (\$108,141.00); and

WHEREAS, in order to fulfill payment of the Work Orders, it is necessary to transfer monies from a contingency line item to the NW 83rd Place Drainage Improvement Project line item, in accordance with Town Section 2 of Ordinance 21-285; and

WHEREAS, the Town Council approves the recommendations of the Town Manager and authorizes the Town Manager to enter into a contract with RG for the NW 83rd Place Drainage Improvement Project.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

- **Section 1. Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.
- Section 2. Approval of the Contract. The Town Council hereby approves the award of a contract to RG Underground Engineering, Inc. in substantially the same form attached

hereto as Exhibit "A" for the NW 83rd Place Drainage Improvement Project in an amount not to exceed One Hundred Eight Thousand, One Hundred Forty One Dollars and 00/100 (\$108,141.00).

Section 3. Authorization of Town Officials. The Town Manager, his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract, in substantially the same form as attached hereto as Exhibit "A."

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of this Resolution and the Contract.

Section 6. Execution of the Contract. The Town Manager is authorized to execute the Contract with RG Underground Engineering, Inc. in an amount not to exceed One Hundred Eight Thousand, One Hundred Forty-One Dollars and 00/100 (\$108,141.00), and to execute any extension and/or amendments to the Contract, subject to approval as to form and legality by the Town Attorney.

Section 7. Line Item Modification. The Budget for Fiscal Year 2021-2022 adopted in Section 2 of Ordinance 21-285 is hereby modified, as reflected in Exhibit "B" attached hereto. The revisions for each fund are within the approved expenditure authority for Fiscal Year 2021-2022. The Town Council hereby modifies the budget as set forth therein and authorizes the Town Manager, or his assign, to administratively adjust line items to reflect audit adjustments and or line-item revisions as necessary.

Section 8. Effective Date. This Resolution shall take effect immediately upon adoption.
