

RESOLUTION NO. 22-1814

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AUTHORIZING THE TOWN MANAGER TO UTILIZE THE SOURCEWELL CONTRACT 101221-VTR WITH VACTOR MANUFACTURING FOR THE ACQUISITION OF A NEW STORMWATER VACUUM TRUCK, PURSUANT TO SECTION 7 OF ORDINANCE 17-203 (THE TOWN'S PROCUREMENT ORDINANCE); AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT AND NEGOTIATE AND EXECUTE A LEASE TO PURCHASE AGREEMENT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 7 of the Town of Miami Lakes Ordinance 17-203 (“the Town’s Procurement Ordinance”) authorizes the purchase of goods and services from current contracts of other public, governmental, state/federal funded or non-profit entities, where the contracts have resulted from a formal competitive procurement process; and

WHEREAS, the Town intends to piggyback the Sourcewell Contract 101221-VTR with Vactor Manufacturing (“Vactor”) (hereinafter referred to as “Contract”) for the purchase of a vacuum truck; and

WHEREAS, Environmental Products Group (“EPG”) is the local representative for the Town of Miami Lakes (“Town”); and

WHEREAS, it is in the Town’s best interest to negotiate a lease-to-purchase agreement not to exceed Budgeted funds with a right to purchase the vehicle at the end of the lease term with Republic First National Bank; and

WHEREAS, the Town Manager recommends authorization to access the piggyback contract for the vacuum truck and authority to negotiate a lease-to-purchase agreement in an amount not to exceed Budgeted funds. Should negotiations fail, the Manager will bring this item back to the Town Council for consideration; and

WHEREAS, the Town Council approves of the Town Manager's recommendations and authorizes the Town Manager to access the piggyback contract for the vacuum truck and authorizes the Town Manager to negotiate and execute the lease-to-purchase agreement for the vacuum truck. Should negotiations fail, the manager will bring this item back to the Town Council for consideration.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the award of a contract to Vactor Manufacturing in substantially the form attached hereto as Exhibit "A" for the vacuum truck, pending favorable negotiation of the lease to purchase agreement with Republic First National Bank.

Section 3. Authorization of Town Officials. The Town Manager and/or his designee are authorized to take all steps necessary to utilize the Sourcewell Contract 101221-VTR and to execute said contract on behalf of the Town, subject to approval as to form and legality by the Town Attorney. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the contract with Vactor

Manufacturing, provided favorable negotiation of the lease to purchase agreement with Republic First National Bank are concluded.

Section 4. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Town Manager by the Town's Procurement Ordinance, the Town Manager is authorized to expend budgeted funds to implement the terms and conditions of this Resolution and the contract with Vactor Manufacturing, Inc, provided favorable negotiation of the lease to purchase agreement with Republic First National Bank is finalized.

Section 5. Execution of the Contract. The Town Manager is authorized to execute the Contract in substantially the form attached hereto as Exhibit "A" with Vactor Manufacturing and to execute any required agreements and/or documents to implement the terms and conditions of the contract and to execute any extension and/or amendments to the contract, subject to approval as to form and legality by the Town Attorney.


Section 6 Negotiation of Lease-to-Purchase Agreement The Town Manager is authorized to negotiate the lease-to-purchase agreement in an amount not to exceed Budgeted funds, execute any required agreements and/or documents to implement the terms and conditions of the lease-to-purchase agreement once negotiated and to execute any extension and/or amendments to the agreement, subject to approval as to form and legality by the Town Attorney.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.

Passed and adopted this 8th day of March 2022.




