

RESOLUTION NO. 22-1853

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE PURCHASE, REMOVAL, AND INSTALLATION OF TWO (2) PLAYGROUNDS IN AN AMOUNT NOT TO EXCEED \$54,362; AUTHORIZING THE TOWN MANAGER TO UTILIZE THE SCHOOL DISTRICT OF MANATEE COUNTY CONTRACT 21-0053-MR WITH PLAYMORE WEST, INC. DBA PLAYMORE RECREATIONAL PRODUCTS AND SERVICES PURSUANT TO CHAPTER 2, ARTICLE V, DIVISION 2, SECTION 2-157 OF THE TOWN CODE; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Miami Lakes (the “Town”) desires the purchase, removal, and installation of two (2) playgrounds (“Services”); and

WHEREAS, Chapter 2, Article V, Division 2, Section 2-157 of the Town Code, authorizes the purchase of goods and services from current contracts of other public, governmental, state/federal funded or non-profit entities, where the contracts have resulted from a formal competitive procurement process; and

WHEREAS, the Town intends to piggyback the School District of Manatee County Contract 21-0053-MR with Playmore West, Inc. dba Playmore Recreational Products and Services (“Playmore”) (hereinafter referred to as “Contract”) for the Services in an amount not to exceed Fifty-Four Thousand, Three Hundred Sixty-Two Dollars and 00/100 (\$54,362.00); and

WHEREAS, the Town Manager recommends authorization to procure the Services from the Contract in an amount not to exceed Fifty-Four Thousand, Three Hundred Sixty-Two Dollars and 00/100 (\$54,362.00); and

WHEREAS, the Town Council approves of the Town Manager’s recommendation.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the award of a contract to Playmore West, Inc., dba Playmore Recreational Products and Services in substantially the form attached hereto as Exhibit “A” for the purchase, removal, and installation of two (2) playgrounds in an amount not to exceed Fifty-Four Thousand, Three Hundred Sixty-Two Dollars and 00/100 (\$54,362.00).

Section 3. Authorization of Town Officials. The Town Manager and/or his designee are authorized to take all steps necessary to utilize the School District of Manatee County Contract 21-0053-MR and to execute said contract on behalf of the Town, subject to approval as to form and legality by the Town Attorney. The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the contract with Playmore West, Inc. dba Playmore Recreational Products and Services for the purchase, removal, and installation of two (2) playgrounds in an amount not to exceed Fifty-Four Thousand, Three Hundred Sixty-Two Dollars and 00/100 (\$54,362.00)

Section 4. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Town Manager by the Town's Procurement Ordinance, the Town Manager is authorized to expend budgeted funds to implement the terms and conditions of this Resolution and the contract with Playmore West, Inc. dba Playmore Recreational Products and Services for the purchase, removal, and installation of two (2) playgrounds in an amount not to exceed Fifty-Four Thousand, Three Hundred Sixty-Two Dollars and 00/100 (\$54,362.00).

Section 5. Execution of the Contract. The Town Manager is authorized to execute the Contract in substantially the form attached hereto as Exhibit "A" with Playmore West, Inc. dba Playmore Recreational Products and Services, and to execute any required agreements and, or documents to implement the terms and conditions of the contract and to execute any extension and, or amendments to the contract, subject to approval as to form and legality by the Town Attorney.


Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.


