

**RESOLUTION NO. 22-1865**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING A TURF AND LANDSCAPE MAINTENANCE AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION (“FDOT”); PROVIDING FOR IMPLEMENTATION; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE AGREEMENT; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Florida Department of Transportation (“FDOT”) controls the roadside area and median strips (“Areas”) throughout the Florida Highway System; and

**WHEREAS**, the Town of Miami Lakes (the “Town”) and FDOT have previously entered into agreements for maintenance of the NW Quadrant of State Road 826 (From NW 154<sup>th</sup> Street to NW 164<sup>th</sup> Terrace), the SW Quadrant of State Road 826 (From NW 82<sup>nd</sup> Avenue to 154<sup>th</sup> Street), the NE Quadrant of State Road 826 (From NW 154<sup>th</sup> Street to 67<sup>th</sup> Avenue), and the SE Quadrant of State Road 826 (From NW 145<sup>th</sup> Street to NW 154<sup>th</sup> Steet) (the “Locations”) pursuant to Resolution No. 04-228; and

**WHEREAS**, Florida Statues 287.058(1)(d) allows the State to reimburse municipalities who elect to maintain State-owned roads located within their boundaries; and

**WHEREAS**, FDOT has agreed to reimburse the Town for the maintenance at the Locations pursuant to a Turf and Landscape Maintenance Agreement (“Agreement”) attached hereto as Exhibit “A;” an

**WHEREAS**, the Town Council finds that authorizing the Town Manager to enter into the Agreement between FDOT and the Town for turf and landscape maintenance is in the best interest of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF  
THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.

**Section 2. Approval of the Contract.** The Town Council hereby approves the Agreement with the Florida Department of Transportation for Turf and Landscape Maintenance, attached hereto as Exhibit “A”, for consideration in the amount of Five Thousand Seven Hundred Eighty-Eight Dollars and 00/100 (\$5,788.00).

**Section 3. Authorization of Town Officials.** The Town Manager and/or his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Florida Department of Transportation, Turf and Landscape Maintenance Agreement. The Town Clerk is hereby directed to send copies of this Resolution to the Florida Department of Transportation and such other persons as is directed by the Town Council of the Town of Miami Lakes.

**Section 4. Authorization of Fund Expenditure.** The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of this Resolution, as may be amended.

**Section 5. Execution of the Contract.** The Town Manager is authorized to execute the Agreement, and any extensions and/or amendments, with the Florida Department of Transportation on behalf of the Town.

**Section 6. Effective Date.** This Resolution shall take effect immediately upon adoption.




