RESOLUTION NO. 22-1873

A RESOLUTION OF THE TOWN OF MIAMI LAKES, FLORIDA, SETTING FORTH LEGISLATIVE PRIORITIES FOR FISCAL YEAR 2023-2024; AUTHORIZING TOWN MANAGER OR HIS DESIGNEE TO PURSUE FUNDING FOR LEGISLATIVE PRIORITIES; AUTHORIZING THE TOWN MANAGER TO EXECUTE ANY AGREEMENT IN FURTHERANCE OF ADVANCING LEGISLATIVE PRIORITIES; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING TOWN CLERK TO REMIT A COPY OF THIS RESOLUTION TO TOWN LOBBYIST, THE SOUTHERN GROUP AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the State of Florida Legislature annually considers appropriation measures which provide discretionary funding for general governmental operations; and

WHEREAS, the Town of Miami Lakes (the "Town") Manager and Town Staff have identified various projects which require funding as described and set forth in Exhibit "A"; and

WHEREAS, The Southern Group ("SG"), together with Sun City Strategies ("SC"), currently provide the Town with lobbying services; and

WHEREAS, with the assistance of SG and SC, the Town Manager is desirous of pursuing State funding for legislative priority projects, set forth in Exhibit "A" ("Legislative Priorities"); and

WHEREAS, in furtherance of advancing the Legislative Priorities, the Town Manager seeks authority to negotiate any agreement, execute any document, and expend necessary funds; and

WHEREAS, in the event that the Town Manager, in consultation with SG, SC, and the Town's State Legislators, find that additional or substitute legislative priorities should be pursued, the Town Manager should be provided discretion to make necessary changes to the Legislative Priorities; and

WHEREAS, the Town Council agrees that it is in the best interest of the Town to pursue the Legislative Priorities set forth in Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

- **Section 1. Recitals.** The foregoing Recitals are true and correct and incorporated herein by this reference.
- Section 2. Approval of Legislative Priorities. The legislative priorities set forth in Exhibit "A", are hereby adopted by the Town Council.
- Section 3. Authorization of Town Officials. The Town Manager and/or his designee are authorized to pursue funding in order to accomplish the legislative priorities set forth in Exhibit "A." Additionally, the Town Manager, in consultation with The Southern Group and Sun City Strategies, and the Town's State Legislators, is authorized to amend and, or augment the Legislative Priorities when in his discretion he believes it is in the best interest of the Town to do so.
- <u>Section 4.</u> Authorization to Execute Agreements. The Town Manager and/or his designee are authorized to negotiate and execute any document necessary and in furtherance of the Legislative Priorities, as described in Exhibit "A," or as amended hereafter.
- <u>Section 5. Authorization to Expend Budgeted Funds.</u> The Town Manager is authorized to expend budgeted funds in furtherance of the Legislative Priorities as described in Exhibit "A," or as amended hereafter.
- <u>Section 6.</u> <u>Authorization of Town Clerk.</u> The Town Clerk and/or her designee are authorized to submit a copy of the Town's recommendations as set forth in Exhibit "A" to the Town's lobbyist, The Southern Group, and to submit a copy of this Resolution to all Florida House of Representative and Senate members currently deliberating passage of these items.
- **Section 7. Effective Date.** This Resolution shall be effective immediately upon adoption.

Town of Miami Lakes Legislative Priorities 2023 – 2024

Water Projects:

- 1) Miami Lakes NW 82nd Avenue Drainage Improvements Project \$1,245,000
- 2) Miami Lakes Montrose Drainage Improvements Project \$742,000
- 3) Miami Lakes West Lakes Gardens Third Addition Drainage Improvements Project \$500,000
- 4) Miami Lakes Royal Gardens Estates Phases II Drainage Improvements Project \$1,600,000
- 5) Miami Lakes Royal Gardens Estates Phases III Drainage Improvements Project \$1,325,000
- 6) Miami Lakes Loch Lomond Phase II Drainage Improvements Project \$920,000
- 7) Miami Lakes Colorama Estates Drainage Improvements Project \$1,470,000
- 8) Miami Lakes Optimist Park Drainage and Stormwater Improvements Project \$10.5 million

Infrastructure/Roads/Bridges:

- 1) Miami Lakes NW 59th Avenue Roadway Extension and Redevelopment Bridge Project \$3,000,000
- 2) Miami Lakes Multipurpose Senior Community Center \$500,000

Statutory/Policy:

Additionally, the legislative statutory/policy amendments include:

- 1) To provide municipalities with the option to extend the senior rebates program to apply to other populations.
- 2) To allow the Save Our Homes Amendment caps of 3% and 10% apply to Miami-Dade County School Board's taxable value increases year over year.
- 3) To designate Miami Lakes as the municipality to study the possibility of the 100% elimination of Town property taxes while the Town keeps up to \$9 million of sales tax revenue collected within town boundaries to pay for our police contract with Miami-Dade County. This pilot program will go into effect and studied during the 2023-24 fiscal year.
 - O State Legislature to consider Miami Lakes as the pilot program, and for the State Legislature to eliminate the Town property taxes from our residents and for the sales revenue derived from our Town, then be geared for paying towards our Police Department.
