RESOLUTION NO. 22-1878

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE AWARD OF CONTRACT FOR ENGINEERING **SERVICES** ROBERTO ALONSO COMMUNITY CENTER STANDBY GENERATOR, RFQ 2022-02 TO A.D.A. ENGINEERING, INC. IN AN AMOUNT NOT TO EXCEED ONE HUNDRED AND TEN THOUSAND, THREE HUNDRED **AND** THIRTY-EIGHT **DOLLARS AND 00/100 (\$110,338.00); AUTHORIZING THE** TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town was awarded a grant from the Florida Department of Economic Opportunity in the amount of Five Hundred Twenty-Five Thousand Dollars and 00/100 (\$525,000.00) for the Roberto Alonso Community Center Standby Generator; and

WHEREAS, the Town issued a Request for Qualifications ("RFQ") No. 2022-02 on April 8, 2022, for Engineering Services for Roberto Alonso Community Center Standby Generator in accordance with Florida Statute § 287.055, the Consultant's Competitive Negotiation Act ("CCNA"); and

WHEREAS, the Town received two (2) proposals by the proposal deadline from (1) A.D.A. Engineering, Inc. ("A.D.A."), and (2) EXP U.S. Services, Inc. ("EXP"); and

WHEREAS, an Evaluation Committee ("Committee") was appointed, comprising of (1) Carlos Acosta, Public Works Director (2) Susana Alonso, Principal Planner, and (3) Jeremy Bajdaun, Director of Parks and Recreation; and

WHEREAS, the Committee met on June 16, 2022, to evaluate and establish a ranking of the responsive proposals; and

WHEREAS, the Committee has determined that A.D.A is the firm most qualified to provide Engineering Services for Roberto Alonso Community Center Standby Generator; and

WHEREAS, the Town and A.D.A. negotiated a fee of One Hundred and Ten Thousand, Three Hundred and Thirty-Eight Dollars and 00/100 (\$110,338.00) for the Engineering Services for Roberto Alonso Community Center Standby Generator; and

WHEREAS, the Town Manager recommends the approval of a contract for Engineering Services for Roberto Alonso Community Center Standby Generator in an amount not to exceed One Hundred and Ten Thousand, Three Hundred and Thirty-Eight Dollars and 00/100 (\$110,338.00); and

WHEREAS, the Town Council approves the recommendations of the Town Manager and authorizes the Town Manager to enter into a contract with A.D.A. Engineering, Inc. for Engineering Services for Roberto Alonso Community Center Standby Generator, in an amount not to exceed One Hundred and Ten Thousand, Three Hundred and Thirty-Eight Dollars and 00/100 (\$110,338.00).

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and incorporated herein by this reference.

Section 2. Approval of the Contract. The Town Council hereby approves the award of a contract to A.D.A. Engineering, Inc. in substantially the form attached hereto as Exhibit "A" for the Engineering Services for Roberto Alonso Community Center Standby

Generator in an amount not to exceed One Hundred and Ten Thousand, Three Hundred and Thirty-Eight Dollars and 00/100 (\$110,338.00).

Section 3. Authorization of Town Officials. The Town Manager, his designee and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the contract with A.D.A. Engineering, Inc. for Engineering Services for Roberto Alonso Community Center Standby Generator

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of this Resolution and the contract with A.D.A. Engineering, Inc.

Section 5. Execution of the Contract. The Town Manager is authorized to execute the contract, in substantially the form attached hereto as Exhibit "A," with A.D.A. Engineering, Inc. in an amount not to exceed One Hundred and Ten Thousand, Three Hundred and Thirty-Eight Dollars and 00/100 (\$110,338.00) and to execute any extension and/or amendments to the contract, subject to approval as to form and legality by the Town Attorney.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
