

**RESOLUTION NO. 22-1880**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE AWARD OF CONTRACTS FOR ITB 2022-38, LITTER CONTROL SERVICES FOR RIGHTS-OF-WAY AND TOWN PARKS TO SFM SERVICES, INC. (PRIMARY) AND SUPERIOR LANDSCAPING & LAWN SERVICES, INC. (SECONDARY) IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO TAKE ALL NECESSARY STEPS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE TOWN MANAGER TO EXECUTE THE CONTRACT; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR AN EFFECTIVE DATE. (Garcia)**

**WHEREAS**, Chapter 2, Article V, Division 2, Section 2-157 of the Town Code provides that procurements in excess of \$15,000 shall require the use of competitive sealed bidding; and

**WHEREAS**, in accordance with Chapter 2, Article V, Division 2, Section 2-157 of the Town Code, the Town issued Invitation to Bid No. 2022-38 (“ITB”) on September 14, 2022, Litter Control Services for Rights-of-Way and Town Parks; and

**WHEREAS**, the ITB was advertised in the Miami Daily Business review and posted online via two public bidding websites, DemandStar and Public Purchase, and was physically posted in the Government Center Lobby; and

**WHEREAS**, the Town received three (3) bids by the bid deadline from the following:

- 1) SFM Services, Inc. (“SFM”)
- 2) Exoalloy
- 3) Superior Landscaping and Lawn Services, Inc. (“Superior”)

**WHEREAS**, based on due diligence, Procurement determined SFM’s and Superior’s bids were responsive; and

**WHEREAS**, Procurement recommended awarding contracts to SFM to act as the primary contractor and Superior to act as the secondary contractor; and

**WHEREAS**, the Town Manager concurs with Procurement's recommendation and recommends the Town Council authorize the award of contracts to SFM to act as the primary contractor and Superior to act as the secondary contractor for Litter Control Services for Rights-of-Way and Town Parks in an amount not to exceed budgeted funds; and

**WHEREAS**, the Town Council approves the recommendations of the Town Manager, and authorizes the Town Manager to enter into contracts with SFM to act as the primary contractor and Superior to act as the secondary contractor for Litter Control Services for Rights-of-Way and Town Parks in amounts not to exceed budgeted funds.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1.**     **Recitals.** The foregoing Recitals are true and correct, and incorporated herein by this reference.

**Section 2.**     **Approval of the Contract.** The Town Council hereby approves the award of contracts to SFM Services, Inc. to act as the primary contractor and Superior Landscaping and Lawn Services, Inc. to act as the secondary contractor in substantially the same form attached hereto as Exhibit "A" for the Litter Control Services for Rights-of-Way and Town Parks in an amount not to exceed budgeted funds (hereinafter referred to as "Contract").

**Section 3.**     **Authorization of Town Officials.** The Town Manager and, or his designee, and the Town Attorney are authorized to take all steps necessary to implement the terms and conditions of the Contract.

**Section 4.**     **Authorization of Fund Expenditure.** The Town Manager is authorized to expend budgeted funds to implement the terms and conditions of this Resolution and the Contract.

**Section 5.**     **Execution of the Contract.** The Town Manager is authorized to execute the contracts with SFM Services, Inc. to act as the primary contractor and Superior Landscaping and Lawn Services, Inc. to act as the secondary contractor for Litter Control Services for Rights-of-Way and Town Parks in an amount not to exceed budgeted funds and to execute any extension and/or amendments to the Contract, subject to approval as to form and legality by the Town Attorney.


**Section 6.**     **Effective Date.** This Resolution shall take effect immediately upon adoption.
