RESOLUTION NO. 23-1962

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, **ADOPTING** THE **INSTITUTE** NATIONAL **STANDARDS** OF AND TECHNOLOGY **CYBERSECURITY FRAMEWORK: PROVIDING FOR INCORPORATION OF RECITALS; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, during the 2022 Florida Legislative Session, Florida Governor Ron DeSantis passed into law Florida Statute § 282.3185 (4)(a), which provides that each local government shall adopt cybersecurity standards that safeguard its data, information technology, and information technology resources to ensure availability confidentiality and integrity; and

WHEREAS, Florida Statute § 282.3185 (4)(c), provides that each municipality with a population greater than 25,000 must adopt a cybersecurity standard by January 1, 2024; and

WHEREAS, the U.S. Department of Homeland Security, Federal Trade Commission has established the National Institute of Standards and Technology, Cyber Security Framework; and

WHEREAS, applying the framework will allow the Town of Miami Lakes (the "Town") to comply with its statutory obligations by creating a policy that will safeguard against internal and external threats; and

WHEREAS, the Town Manager recommends that the Town Council adopt the National Institute of Standards and Technology Cybersecurity Framework in substantially the same manner as attached hereto as Exhibit "A."

WHEREAS, the Town Council finds that it is in the Town's best interest to adopt the National Institute of Standards and Technology Cybersecurity Framework in substantially the same manner as attached hereto as Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL FOR THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing recitals are true and correct and are incorporated herein by reference.

<u>Section 2. Adoption of the National Institute of Standards and Technology</u> <u>Cybersecurity Framework.</u> The Town of Miami Lakes, Town Council hereby adopts the United States of America, National Institute of Standards and Technology, Cybersecutiry Framework, in conformity with Florida Statute § 282.3185. Section 3. Effective Date. This Resolution shall be effective immediately upon adoption.
