Mayor Michael Pizzi called the meeting to order at 6:40 p.m.

A. Town of Miami Lakes Budget Revisions

1. All America City Funding

Mayor Michael Pizzi made a motion to take \$2,500.00 from each of the Committees for a total of \$15,000.00 with some conditions. Condition # 1; continue the efforts of private fund raising before using the Committees' funds. Condition # 2; Any Committee is welcome to come to the June or July Council Meeting to ask for a replacement of their funds.

Finance Director, Michael Appleton, identified some funds that could be placed on hold to be used for the All America City Funding. Some of those funds are; \$1,000.00 from Council Discretionary Funds, \$4,000.00 from the Clerk's Budget, \$6,000.00 Administrative Travel and \$4,000.00 from Council Travel. The motion received a second from Councilmember Meador and all voted in favor with Vice Mayor Perdomo absent from the dais.

Councilmember Collins made a motion to re-allocate \$12,000.00 within the Cultural Affairs Committee for the 4th of July event. The motion received a second from Mayor Pizzi and all voted in favor. Vice Mayor Perdomo was absent.

Councilmember Mary Collins excused herself from the meeting at 7:10 p.m.

2. Financial Consultant Contract

Mayor Michael Pizzi made a motion to approve the contract with Estrada Hinojosa as Interim Finance Consultants. Councilmember Pulido made an amendment to waive the hiring freeze on the Finance Director position. Mayor Pizzi amended the motion to change the contract to include a minimum of twenty (20) hours a week in house services and to take out the "Out of pocket expenses" from the contract. The motion received a second from Councilmember Lopez and all voted in favor. Vice Mayor Perdomo was absent.

3. First Amendment- Royal Oaks Park Maintenance Agreement with South Florida Maintenance Services

Mayor Michael Pizzi made a motion to approve the extension of the contract with South Florida Maintenance Service on a month to month basis. The motion received a second from Councilmember Simon and all voted in favor. Vice Mayor Perdomo was absent.
