# **MINUTES**

SPECIAL CALL COUNCIL MEETING

December 8, 2010 5:00 PM TOWN HALL

#### 1. CALL TO ORDER:

Mayor Michael Pizzi called the meeting to order at 5:20 p.m.

### 2. ROLL CALL:

Marjorie Tejeda, Town Clerk, called the roll with the following Councilmembers present: Nelson Hernandez, Ceasar Mestre, Mary Collins, Tim Daubert and Mayor Michael Pizzi. Councilmember Richard Pulido and Vice Mayor Perdomo were absent.

There was a motion to allow Vice Mayor Perdomo to teleconference into the meeting by Councilmember Collins. The motion received a second from Mayor Pizzi and all who were present voted in favor.

#### 3. PLEDGE OF ALLEGIANCE/MOMENT OF SILENCE

Esperanza Hope Reynolds led the Pledge of Allegiance and the Mayor called for a moment of silence.

Howard Watson spoke in favor of Town Hall being located on Main Street and supports the purchasing of a Town Hall immediately.

Esperanza Hope Reynolds spoke about e-mail communication issues that she is having with the Town.

Fred Senra spoke in favor of purchasing and building a new Town Hall. He also spoke in favor of the resolution.

Norma Franquiz spoke in favor of building a new Town Hall.

Jan Scheider spoke in favor of building a new Town Hall.

Bob Madden spoke in opposition of the process being used to build the new Town Hall and would prefer the issue voted upon a new Town Hall.

Mirtha Mendez spoke in favor of purchasing; but not in favor of the amount of the bond and she would like the issue to be put out to the voters.

Jeanne White spoke in favor of purchasing; but not in favor of the amount of the bond and she would like the issue to be put out to the voters.

John Tingle spoke in favor of the resolution.

Ladd Howell reiterated his comments in support of the resolution.

Jorge De Apodaca implored the Council to support the resolution.

Jeanne White voiced her concerns about the amount being borrowed.

David Bennett voiced his concerns about the process being used to buy the new Town Hall and urged the Council to utilize all financial options open to them.

Councilmember Tim Daubert voted in opposition. Councilmember Pulido and Vice Mayor Perdomo were absent.
