Joe Geller, Town Attorney, read the title of the ordinance into the record. The Mayor made the motion to adopt the ordinance on first reading. Councilman Cid seconded the motion. The Town Clerk called the roll and all were in favor.

Joe Geller, Town Attorney, read the title of the resolution into the record. Alex Rey, Town Manager, read the millage rate and two budget hearing dates into the record. Mayor Pizzi made a motion to adopt the resolution and it received a second from Councilman Lama. All were in favor. Alex Rey, the Town Manager, stated that the roll back rate is 4.72%. Mayor Pizzi amended the motion for it to include the roll back percentage rate and it was seconded by Councilman Cid. All were in favor.

12. NEW BUSINESS:

A. Opa-Locka West Lease (Pizzi)

Mayor Pizzi made a motion to modify the Resolution for it to read the following way..."WHEREAS, the Town of Miami Lakes, hereby, opposes the County permitting any mining activity on county land without first meeting with the Town of Miami Lakes to ensure the protection and quality of life of our residents."

The motion received a second from Councilman Daubert and all were in favor. The Mayor requested staff to send a copy of the Resolution to the Aviation Department and to invite them to attend to the September Council Meeting.

Felix Acosta, owner of Acosta Contractors, personally thanked the Town Council for awarding his company the contract for ITB 2013-39, NW 154th Street Roadway & Drainage Improvements, Item 8E.

B. Beautification Master Plan Report Follow-up (Mestre)

Vice Mayor Mestre made a motion to implement the Beautification Master Plan and to implement the Bismark Palms and pavers. Mayor Pizzi supported the motion subject to further discussion at the Budget Workshop. Town Manager, Alex Rey stated that \$200,000.00 would be set aside to next years' Budget, for the Beautification Master Plan and that Bid Packages would be available for the September Council Meeting. The motion received a second from Councilman Cid and all were in favor.

C. Miami Lakes Planning and Zoning (Cid)

The Town Council discussed some historical aspects of the Planning & Zoning Board and no action was taken.

D. Change in Voting Laws (Rodriguez)

Councilman Rodriguez made a motion asking staff to bring back to the September Council Meeting, a Resolution recommending State Legislature to make changes in Voting Laws. The motion received a second from Mayor Pizzi and all were in favor.

E. Lake Water Quality- Landscaper Registration (Lama)

Councilman Lama made a motion directing staff to publicize and to educate voluntarily all landscapers in the Town of Miami Lakes and to recognize the best practices in lake maintenance and lake awareness. Councilman Lama stated that the Public Information Officer of the Town would educate the residents of the "best practices" for lake maintenance via the publication of a pamphlet. The motion received a second from Councilman Hernández and all were in favor. Councilman Rodriguez made a friendly amendment to publish the "best practices" pamphlet in English and Spanish. Councilman Lama accepted the friendly amendment.

Alex Ariano spoke in opposition of item 12E.

F. Watercraft Code Provisions (Pizzi)

Mayor Pizzi deferred item 12F.

G. Workshop: Parliamentary Procedures (Cid)

Councilman Cid discussed the importance of understanding parliamentary procedures. Mayor Pizzi asked Town Attorney, Joe Geller, to put together a package for the better understanding of parliamentary procedures.

4. 1st Annual Family Fishing Clinic (Cid)

Councilman Cid reported on the success of the first Family Fishing Clinic.

5. All America City (Pizzi)

Mayor Pizzi presented All America City participants with a certificate of appreciation.
