Chairman Lopez made a motion to move variance request #2 with the following condition; to allow one (1) foot of Bamboo wall. The Deputy Town Clerk called the roll and the motion failed 5-1. Vice Chairman Carballo voted in support of the motion and Board Member Senra was absent.

Board Member De La Sierra made a motion to revisit motion #1, approving the first variance, Request #1, with the condition that Applicant shall obtain a demolition permit to remove the bamboo topping on the existing wall. The motion received a motion from Chairman Lopez. The Deputy Town Clerk called the roll and the motion passed, 5-1. Vice Chairman Carballo voted in opposition and Board Member Senra was absent.
