#### A. Approval of Minutes

Board Member Raul de La Sierra made a motion to accept the minutes from May 21, 2013. The motion received a second from Board Member Lorenzo Cobiella and all were in favor.

Brandon Schaad, Senior Planner of the Town of Miami Lakes, presented the item and answered questions posed by the Board.

Chairman Lopez opened the public hearing.

Applicant, Max Freira, spoke on behalf of the item.

There being no one else wishing to speak, the public hearing was closed.

Chairman Lopez made a motion to approve the variance with the following conditions: only the center flagpole may be up to twenty-five (25) feet high and all three (3) flagpoles each with a setback of four and one-half (4.5) feet from the front property line; all flagpoles shall be staggered evenly and the northernmost and southernmost flagpoles shall be limited to a maximum height of twenty (20) feet high; only one (1) flag shall be allowed per flagpole and only the following flags shall be allowed: United States of America, Florida State Flag and the flag of Serenity Pointe. The motion received a second from Board Member De La Sierra. The Deputy Town Clerk called the roll and the motion passed 4-2. Board Member Senra and Vice Chairman Carballo voted in opposition to the motion. Board Member Padron-Fragetta was absent.
