MINUTES Regular Council Meeting June 10, 2014 6:30 PM

1. CALL TO ORDER:

Mayor Slaton called the meeting to order at 6:58 p.m.

2. **ROLL CALL:**

The Town Clerk, Marjorie Tejeda, called the roll with the following Councilmembers present: Frank Mingo, Nelson Rodriguez, Tony Lama, Ceasar Mestre, Vice Mayor Manny Cid, and Mayor Wayne Slaton. Councilman Daubert was absent.

3. INVOCATION/MOMENT OF SILENCE:

Father Jack Stanton led the invocation.

4. PLEDGE OF ALLEGIANCE:

Boy Scout troops 529 led the Pledge of Allegiance and Call to Colors.

5. PUBLIC COMMENTS:

Martha Gonzalez expressed her support for Item 12B.

Mirtha Mendez thanked Councilman Lama for proposing Item 8F and also expressed the importance of discussing a proposed item and subsequently providing the staff with specific instructions. She, furthermore, suggested that Council forgo the proposition of big tickets items under the Consent Agenda and instead recommended that it be listed under Resolutions in order to dedicate more discussion time to the item.

Via Remote Services, Michael Mut expressed his concerns and made a recommendation with respect to calming traffic on Alamanda Avenue.

Vice Mayor Cid pulled Item 8D and 8F. Councilman Mingo made a motion to approve the agenda as amended. The motion was seconded by Councilman Rodriguez and all were in favor.

Councilman Lama made a motion to amend the existing resolution, thereby requesting that staff provide an analysis of all soft and hard costs before the item returns to the Council in the form of a resolution. The motion was seconded by Councilman Mestre.

Vice Mayor Cid withdrew his motion.

Councilman Mestre made a motion to defer the item. The motion was seconded by Councilman Rodriguez and the motion passed 5-1. Councilman Lama voted in opposition and Councilman Daubert was absent.

11. RESOLUTIONS:

A. A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, ESTABLISHING THE PER SPACE FEE FOR THE PAYMENT-IN-LIEU OF PARKING PROGRAM AUTHORIZED BY ORDINANCE 14-166; PROVIDING FOR THE OPTION BY AN APPLICANT TO CONSTRUCT IMPROVEMENTS UNDER THE PAYMENT-IN-LIEU OF PARKING PROGRAM; PROVIDING FOR THE OPTION BY AN APPLICANT TO UNDERTAKE MAINTENANCE ACTIVITIES RELATED TO ON-STREET PARKING; AND PROVIDING FOR AN EFFECTIVE DATE. The Town Attorney, Raul Gastesi, read the title of the resolution into the record.

The Mayor opened the public hearing.

As no one wished to speak, the Mayor closed the public hearing.

Councilman Mestre made a motion to approve the resolution. The motion was seconded by Councilman Mingo and the motion passed 6-0.

12. NEW BUSINESS ITEM:

A. Real Traffic Relief for the Town of Miami Lakes (Lama)

Councilman Lama made a motion directing staff to request further information from Miami-Dade Expressway Authority (MDX) with respect to the prospects of providing access from NW 67th Avenue to Gratigny Parkway, thereby alleviating traffic congestion and providing alternative access to and from the area. Furthermore, Councilman Lama requested that MDX report its findings back to the Town Council via collaboration with the Town Manager. The other part of the motion requests the implementation of the extension of State Road 924 (also known as Gratigny Parkway) to the Turnpike to NW 138th Street, which is now a project that's currently in environmental and developmental stages. The motion received a second from Councilman Mestre and all were in favor. Councilman Daubert was absent.

B. National & State Motto (Cid)

Vice Mayor Cid made a motion to support Martha Gonzalez's efforts in fundraising to place a plaque in the Town Hall, which would commemorate the 150th anniversary of the National and State Motto: "In God we trust." The motion received a second from Councilman Mestre.

Councilman Mestre withdrew his motion.

Vice Mayor Cid amended his original motion, thereby establishing a committee of the whole to further discuss the item. The motion was seconded by Councilman Mestre and the motion passed 6-0.

C. Operation SAFE Flight (Mingo)

Councilman Mingo made a motion directing staff to allocate \$2,000 from the General Funds Reserves. The Program Director provided insight and answered questions. The motion received a second from Councilman Rodriguez and the motion passed 6-0.

D. Marina (Cid)

Vice Mayor Cid made a motion directing staff to explore the prospects of fund allocation for a shade structure that will enhance the residences' marina experience. The motion was seconded by Councilman Mestre and the motion passed 6-0.

13. MAYOR AND COUNCIL MEMBER REPORTS:

A. Appointments

Robert Acosta was nominated to the Neighborhood Improvement Committee by Councilman Lama.

Jose Contero was nominated to the Neighborhood Improvement Committee by Councilman Mingo.

Jose Diaz Grazier was nominated to the Cultural Affairs Committee by Councilman Lama.

The Mayor appointed all of the nominees. Vice Mayor Cid made a motion to accept the appointments. The motion was seconded by Councilman Mestre and the motion passed 6-0.

B. Does It Work? 9 Key Steps to Testing a Policy (Cid)

Vice Mayor Cid deferred this item to July.

14. MANAGER'S REPORTS:

A. Lobbyist Report

Fatima, Southern Strategy spokesperson, provided a presentation on the outcome of the legislative session.

15. ADJOURNMENT:
