MINUTES Regular Council Meeting October 28, 2014 6:30 PM Government Center 6601 Main Street Miami Lakes, Florida 33014

PRESENTATIONS:

The Mayor and Council presented Miami Lakes Congregational Church with a proclamation in honor of its 50th Anniversary.

Judge Soto and Judge Bailey made a presentation to the Council regarding the poor condition of the Dade County Courthouse and encouraged voters to vote in favor of bond question #168 on the ballot.

1. CALL TO ORDER:

Mayor Slaton called the meeting to order at 7:10 p.m.

2. ROLL CALL:

The Town Clerk, Marjorie Tejeda-Castillo, called the roll with the following Councilmembers present: Frank Mingo, Nelson Rodriguez, Tim Daubert, Tony Lama, Ceasar Mestre, Vice Mayor Manny Cid, and Mayor Wayne Slaton.

3. INVOCATION / MOMENT OF SILENCE

Pastor Richard Sparrow from the Miami Lakes Congregational Church led the invocation.

4. PLEDGE OF ALLEGIANCE:

Boy Scout Troop 49 led the Pledge of Allegiance.

5. PUBLIC COMMENTS:

Juan Jose Leon spoke about the Tree Canopy Protection Act.

Mirtha Mendez spoke about an email sent by David Bennett to the Council and asked the Council to address the concerns mentioned in the email and to investigate further.

David Bennett thanked the Town Manager for correcting the email issue.

Councilman Mestre made a motion to approve the agenda. The motion was seconded by Councilman Lama and all were in favor.

Vice Mayor Cid made a motion to eliminate the alarm registration fee of \$15. The motion was seconded by Councilman Lama. The Town Clerk called the roll and the motion passed 5-2 with Councilman Rodriguez and Mayor Slaton voting in opposition.

Vice Mayor Cid made a motion to adopt the ordinance as amended. Councilman Daubert seconded the motion. The Town Clerk called the roll and the ordinance was adopted unanimously on first reading.

Mayor Slaton opened the public hearing.

As no one wished to speak, the Mayor closed the public hearing.

Councilman Daubert made a motion to adopt the ordinance on second reading. The motion was seconded by Councilman Lama. The Town Clerk called the roll and the ordinance was adopted 5-2 with Councilman Mingo and Vice Mayor Cid voting in opposition.

Councilman Mingo made a motion to amend the ordinance to eliminate the increase of the residential permit fee proposed in the ordinance. The motion was seconded by Councilman Lama. The motion passed 6-1 with Mayor Slaton voting in opposition.

Councilman Mestre made a motion to adopt the ordinance on second reading as amended. The motion received a second from Councilman Rodriguez. The Town Clerk called the roll and the ordinance was adopted 6-1 with Vice Mayor Cid voting in opposition.

Councilman Daubert made a motion to adopt the resolution. The motion was seconded by Councilmember Rodriguez. The Town Clerk called the roll and the motion passed unanimously.

12. **NEW BUSINESS:**

A. Par 3 Council Workshop (Mingo)

Councilman Mingo made a motion recommending that the Council hold a workshop in January 2015 to discuss the Par 3 Committee's recommendation. The motion was seconded by Councilman Mestre and all were in favor.

B. Miami Lakes Branch Library (Cid)

Vice Mayor Cid made a motion recommending that the staff bring back a resolution urging that funds stay in the Town of Miami Lakes. The motion received a second from Councilman Mestre and all were in favor.

13. MAYOR AND COUNCILMEMBER REPORTS:

A. Appointments

Juan Fernandez was nominated by Vice Mayor Cid to the Neighborhood Improvement Committee.

Yefrei Musa was nominated by Vice Mayor Cid to the Economic Development Committee.

The Mayor appointed the nominees to their respective committees and all Councilmembers were in favor.

B. FLC Growth Management & Economic Development Committee (Cid)

Vice Mayor Cid reported on his attendance at the above-mentioned meeting, which discussed the importance of fostering Enterprise Zones throughout the State and its impact on municipalities. He also reported that he will be a panelist at the University of Central Florida to discuss innovative ways to engage millennials in government.

14. MANAGER'S REPORT:

A. Proposed Dog Recreation Area Concept Plan

Alex Rey, Town Manager, presented the development status of the proposed Dog Park, which requires the community's feedback concerning the preliminary design of the park. Subsequently, the input will be reported back to the Council by January's Council Meeting.
