MINUTES Regular Council Meeting January 13, 2015 6:30 PM Government Center 6601 Main Street Miami Lakes, Florida 33014

PRESENTATIONS:

Mayor Slaton recognized Christina Delgado, Vice-Chair of the Youth Activities Task Force, for her passionate commitment to public service, as she recently was awarded the national President's Volunteer Service Award granted by The Prudential Spirit of Community Awards program on behalf of President Barack Obama.

Mayor Slaton presented Councilman Tim Daubert with a special certificate from the Miami-Dade Commission on Ethics and Public Trust for his participation as a guest speaker on Ethical Governance Day.

Mayor Slaton recognized Councilman Nelson Rodriguez for his successful completion of the "Leaders of Excellence Program" offered by the Good Government Initiative.

Representatives from the Miami-Dade County Water and Sewer Department conducted a presentation concerning the WASA pump station #334 project and its direct effect on the Town.

1. CALL TO ORDER:

Mayor Slaton called the meeting to order at 7:00 pm

2. ROLL CALL:

The Town Clerk, Marjorie Tejeda-Castillo, called the roll with the following Councilmembers present: Frank Mingo, Nelson Rodriguez, Tim Daubert, Ceasar Mestre, Vice Mayor Manny Cid, and Mayor Wayne Slaton. Councilman Tony Lama attended the meeting via skype.

3. INVOCATION /MOMENT OF SILENCE:

Father Joseph Lucas, pastor at Christ the Savior Orthodox Church, led the invocation.

4. PLEDGE OF ALLEGIANCE:

Boy Scout Troop #660 posted the colors and led the Pledge of Allegiance

5. PUBLIC COMMENTS:

Gloria Garcia spoke about the Miami Lakes Relay for Life, which will be held on May 2nd at the Optimist Park.

Mirtha Mendez voiced her opposition to the opening of 154th Street and recommended that the prospective overpass of 170th also be added to the resolution.

Claudia Luces spoke on behalf of the Education of Advisory Board and expressed her approval of the revised MDCPS Compact, item 8.G

Alex Ariano shared his disapproval of the Town Council's unanimous decision to seek legal representation.

Hope Esperanza Reynolds expressed her disapproval regarding her email not being read into the record at the 1-9-2015 Special Call Meeting. She also was dissatisfied with the Council's decision to seek legal representation.

Juan Valiente expressed his dissatisfaction regarding technical difficulties with two public records request discs.

Juan Breniella spoke about his son's solution to enhance the Town's conservation efforts.

Rafael de la Cola presented a plan for conservation and maintenance of a proposed garden at Poetry Park.

Bonny Crook expressed concern regarding the concrete wall on Sabal Drive, which is open due to construction. This provides access to animals, such as alligators to enter Lake Sarah, thereby posing a threat to the community.

Carlos Gonzalez spoke about Poetry Park noise and safety issues that affect neighboring residents. He advocated for the natural restoration of tree canopies in Poetry Park.

Antonio Moreno recommended the natural restoration of the park's ecosystem. He expressed concern regarding the demolition of the park's wall, as it may cause further issues.

Town Manager, Alex Rey deferred item 8E and pulled 8G. Vice Mayor Cid moved item 14A, Poetry Park on Sabal Drive to be discussed after the consent agenda. Councilman Mestre made a motion that the agenda be approved as amended. The motion received a second from Councilman Daubert and all were in favor.

Youth Activities Task Force Report

Lynn Matos, Chairwoman of the Youth Activities Committee, presented the Committee's Report and thanked staff for their efforts in supporting the committee's initiatives.

Councilman Daubert made a motion to adopt the ordinance on first reading. The motion was seconded by Councilman Mingo. The Town Clerk called the roll and the ordinance passed 6-0. Councilman Rodriguez was not present during the roll call.

The Town Attorney, Raul Gastesi, read the title of the ordinance into the record.

Town Planner, Brandon Schaad, presented the item.

Mayor Slaton opened the public hearing.

As no one wished to speak, the Mayor closed the public hearing.

Councilman Mestre made a motion to adopt the ordinance on second reading. The motion was seconded by Councilman Rodriguez. The Town Clerk called the roll and the ordinance was adopted unanimously.

11. RESOLUTIONS:

The Town Attorney, Raul Gastesi, read the title of the resolution into the record.

Town Manager Alex Rey presented the conceptual design of the dog recreation area.

Vice Mayor Cid made a motion to adopt the resolution. The motion was seconded by Councilman Mestre. The Town Clerk called the roll and the motion passed unanimously.

The Town Attorney, Raul Gastesi, read the title of the resolution into the record.

Councilman Mestre made a motion to add the item to the agenda for discussion and action pursuant to Section 7.3 of the Council Meeting Rules and Procedures. The motion was seconded by Councilman Daubert and all were in favor.

Town Manager, Alex Rey, presented the solicitation process concerning this item.

Councilman Daubert made a motion to adopt the resolution. The motion was seconded by Councilman Mestre. The Mayor called for the vote and the motion passed unanimously.

12. **NEW BUSINESS:**

A. MDX Resolution (Cid)

Vice Mayor Cid made a motion directing staff to present a resolution at the February Meeting which requests Miami-Dade Expressway Authority to afford the residents of the Town the same toll discount offered to five-axle trucks. Councilman Mestre seconded the motion and it passed unanimously.

B. 154th Street Overpass (Mestre/Rodriguez)

* This item requires a vote to waive Section 7.2 of the Council Meeting Rules and Procedures

Councilman Rodriguez made a motion to waive Section 7.2 of the Council Meeting Rules and Procedures. Councilman Mingo seconded the motion and all were in favor.

Councilman Mestre made a motion to bring back a resolution at the next Council Meeting for the Miami –Dade Commission, thereby expressing opposition to the opening of 154th Street overpass. Councilman Rodriguez seconded the motion. The Motion passed 6-1 with Councilman Lama voting in opposition.

13. **APPOINTMENTS:**

A. Councilman Lama appointed Yaima Vega to the Neighborhood Improvement Committee and Public Safety Committee. Councilman Mestre appointed Alfredo Cansania to the Public Safety Committee. Vice Mayor made a motion to accept the appointment for the aforementioned candidates. The motion received a second from Councilman Mestre and all were in favor.

14. MANAGER'S REPORT:

A. Poetry Park on Sabal Drive (Rey/Cid)

Town Manager, Alex Rey, appointed Mr. Rafael de la Cola as Special Advisor to the Town Manager on conservation affairs.

Councilman Rodriguez made a motion to donate \$142 to Rafael de la Cola's college fund. The motion was seconded by Councilman Mingo.

Mayor Slaton matched Councilman Rodriguez's donation and challenged the rest of the Council to do the same. Subsequently, the following Councilmembers matched the funds: Frank Mingo, Ceasar Mestre, Manny Cid, Tony Lama, and Tim Daubert. The Town Manager, Town Attorney, and the Town Clerk also matched the funds.

The motion passed unanimously.

B. Mobile Application, Citizen Response Module (Rey/Lama)

This item was presented by Nicole Singletary, Community & Leisure Services Director. Councilman Lama spoke about the marketing effort and answered questions posed by the Council.

15. ATTORNEY'S REPORT:

A. Settlement Proposal: JRT Construction Co. v. The Town of Miami Lakes

Raul Gastesi presented the settlement offer from JRT Construction for \$155,000 and asked that Council accept the offer, thereby authorizing the Town Manager, Alex Rey, to transfer \$65,000 from the Park Capital Development Program line item into the respective line item.

Councilman Mestre made a motion to approve the settlement. The motion was seconded by Councilman Daubert and all were in favor.

ADJOURNMENT:

There being no further business to come before the Council, the meeting adjourned at 8:45 p.m.
