## 1. CALL TO ORDER:

Mayor Slaton called the meeting to order at 6:35 p.m.

## 2. ROLL CALL:

## 3. MOMENT OF SILENCE

Mayor Slaton called for a moment of silence.

Albert Gonzalez, the architect of record for the application, spoke in favor of the application.

There being no one else wishing to speak, the Mayor closed the public hearing.

The Town Attorney reviewed the revisions on the substitute resolution.

Councilman Mestre made a motion to adopt the resolution with the proposed revisions. Councilman Rodriguez seconded the motion and the resolution was adopted unanimously.

Brandon Schaad, Brandon Schaad, Director of Planning, Zoning and Code Enforcement, gave an update on the proposed cellular tower and answered questions posed by Council.

## 16. ATTORNEY'S REPORT:

#### A. United States Postal Service ZIP Code

The Attorney, Raul Gastesi, gave an update on the ZIP Code request to the USPS.

Vice Mayor Cid thanked Congressman Mario Diaz-Balart for writing a letter the post master general supporting our efforts to obtain a town wide ZIP code.

# B. Pizzi v. Town of Miami Lakes - Status & Legal Representation

Mayor Slaton recused himself, turning the meeting over to Vice Mayor Cid to chair for the remainder of the meeting.

The Town Attorney made a request of the Council to fund \$111,000 to cover all costs of the appeal process. Councilman Mingo made a motion to accept the Town Attorney's request. The motion was seconded by Councilman Daubert. The Town Clerk called the roll and the motion passed 5-1 with Councilman Lama voting in opposition.
