Vice Mayor Cid opened up the public hearing.

Applicant, Andy Perez, spoke in favor of the item and answered questions posed by the Council.

Councilman Mestre made a motion to amend the resolution allowing the business to open Monday through Friday from 9:00 a.m - 4:00 p.m, and Saturdays from 10:00 a.m - 5:00 p.m. The motion received a second from Councilman Daubert. The Town Clerk called the roll and the motion passed 5-0. Mayor Pizzi and Councilman Lama were absent.

B. Mayor Pizzi made a motion to approve the resolution as written. The motion

received a second from Councilman Mingo and all were in favor.

Mayor Pizzi excused himself from the meeting at 12:00 a.m.

#### 13. **NEW BUSINESS:**

# A. EKG's to save lives (Mestre / Rodriguez)

Councilman Mestre made a motion requesting that a resolution be brought back to the Council in September implementing a comprehensive policy. The motion received a second from Councilman Rodriguez and all were in favor.

Councilman Rodriguez made a motion to pass the resolution on to other cities and municipalities as well as to the state in order to enact the "Brianna Saves Lives" Act statewide. The motion received a second from Councilman Mestre and all were in favor.

Mayor Pizzi called for a five minute recess at 8:47 p.m. Mayor Pizzi called the meeting to order at 8:52 p.m.

### B. Town Sponsored Events (Lama / Rodriguez)

Councilman Lama made a motion requesting that a resolution be brought back to the Council amending the Council rules and procedure. The amended rules and procedures would state that Town email, letterhead, and all Town resources only be used for official Town business, if an announcement for an event is required, events that have been publicly noticed and or approved by the Council, Town Manager, or a Committee. The motion received a second from Councilman Rodriguez. The Town Clerk called the roll and the motion passed 6-1 with Mayor Pizzi voting in opposition.

Vice Mayor Cid made a motion to extend the meeting until 1:00 a.m. The motion received a second from Councilman Mingo and all were in favor.

Mayor Pizzi made a motion to move item 12B up for discussion after the Committee reports and special presentation. The motion received a second from Councilman Mingo and all were in favor.

Councilman Lama excused himself for the remainder of the meeting at 11:13 p.m.

# C. Section 5.1 of the Special Rules of Order of the Town of Miami Lakes (Rodriguez)

Councilman Rodriguez made a motion directing staff to bring back a resolution amending the Council Rules and Procedures requiring that the Clerk collect and call the

speakers to the podium in the order in which the cards were received. The motion received a second from Councilman Mestre and all were in favor. Mayor Pizzi and Councilman Lama were absent.

# D. Complete Streets (Cid / Rodriguez)

Vice Mayor Cid made a motion to waive the Council Rules and Procedures to allow for a presentation on the item. The motion received a second from Councilman Rodriguez and all were in favor. Mayor Pizzi and Councilman Lama were absent.

Geoffrey Shideler gave a presentation and answered questions posed by the Council.

#### E. Training Workshop on Robert Rules of Order (Mingo)

Councilman Mingo made a motion directing the Town Manager to direct staff to coordinate a training workshop on Robert's Rules of Order for the Town Council to participate. The motion received a second from Councilman Rodriguez and all were in favor. Mayor Pizzi and Councilman Lama were absent.

### F. Homeowner Protection Act (Pizzi)

Mayor Pizzi made a motion for an ordinance to be brought back to the Council modifying our Town Code in the appropriate place to state: In order to protect the quality of life of all homeowners in Miami Lakes, the code be amended to prohibit any owner of a lot in a residential subdivision that is already built out from subdividing the lot into more than one dwelling unit where for more than ten years the lot has consisted of one residential unit regardless of the ownership. This is needed in order to protect the homeowners of Miami Lakes from traffic, school overcrowding, and quality of life issues. The motion received a second for discussion from Councilman Mingo.

Councilman Mingo made a motion amending Mayor Pizzi's motion to state that any legislation that is brought back to the Council must require that the Loch Ness Homeowner Association indemnify the Town and pay any legal costs the Town may face due to a lawsuit. The motion received a second from Councilman Mestre.

Councilman Lama made a motion to table Mayor Pizzi's original motion which supersedes all previous motions. The motion received a second from Councilman Mestre. The Town Clerk called the roll and the motion passed 6-1 with Mayor Pizzi voting in opposition.

# G. Support of County Charter Amendment (Cid)

Vice Mayor Cid made a motion directing staff to bring back a resolution to the Council supporting Charter Amendments which Commissioner Bobo is sponsoring. The motion received a second from Councilman Daubert and all were in favor. Mayor Pizzi and Councilman Lama were absent.

### H. Senior Services (Pizzi)

Councilman Mingo made a motion recommending that the Council pass a resolution requesting that the Miami-Dade County School Board, either through its exiting budget or community partnerships, fund the Adult Education Programs that are currently serving the seniors in our Town and surrounding communities which are held within Miami Lakes. The motion received a second from Councilman Mestre and all were in favor. Mayor Pizzi and Councilman Lama were absent.

# I. Resolution in Opposition of Diplomatic Office in Miami-Dade County (Cid)

Vice Mayor Cid made a motion directing staff to draft a resolution in opposition of any Diplomatic Office opening up in Miami-Dade County. The motion received a second from Councilman Mingo and all were in favor. Mayor Pizzi and Councilman Lama were absent.

# J. Budget Reform Act (Pizzi)

This item was deferred.

# K. Air Conditioning Screen Enclosures (Pizzi)

Mayor Pizzi made a motion requesting that the air conditioning screen enclosure restriction be removed. The motion received a second from Councilman Daubert.

Mayor Pizzi amended his motion directing staff to prepare legislation to remove the restriction and workshop this issue between now and the time that the legislation was brought back to the Council. He also proposed that the Town Manager come to an agreement with the staff, restricting them from engaging in enforcement efforts while the legislation is pending. The motion died due to lack of second.

Mayor Pizzi amended his motion requesting that the Council vote on the restriction being removed immediately, with the understanding that workshops would take place in order to formulate the proper legislation. The motion received a second from Councilman Lama. The Town Clerk called the roll and the motion passed 7-0.

Councilman Rodriguez made a motion to appoint Mrs. Inguanzo as the new Town Clerk. The motion received a second from Councilman Mestre and all were in favor. Mayor Pizzi and Councilman Lama were absent.
