

**RESOLUTION NO. 02-56**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, ESTABLISHING THE "KEY TO THE TOWN OF MIAMI LAKES SCHOLARSHIP;" AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town Council desires to promote academic excellence, encourage the development of leadership skills and recognize students that have demonstrated extraordinary commitment to their school and the community; and

**WHEREAS**, the Town Council desires to establish a scholarship to recognize two outstanding high school seniors each year that reside in the Town of Miami Lakes (the "Town").

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:**

**Section 1.** The Town Council hereby establishes the "Key to the Town of Miami Lakes" scholarship (the "Scholarship").

**Section 2. Scholarship.** The Scholarship shall be awarded beginning in June of 2002 and for the next two (2) years thereafter to a male and a female graduating senior that resides in the Town. Scholarship recipients shall receive (i) a \$500.00 scholarship sponsored by The Keyes Company; (ii) an official "Key to the Town of Miami Lakes;" and (iii) a recognition certificate from the Town. The recipients shall receive their scholarships at a regularly scheduled Town Council meeting during the month of June.

**Section 3. Application Packages.** Applicants shall submit the following items to the Town Clerk by no later than May 1<sup>st</sup> of each year.

1. An essay of 750 words or less describing the applicant's personal and educational goals.
2. A cover sheet with the following information:
  - i. The applicant's name, address, and telephone number.
  - ii. The name of the applicant's high school.
  - iii. The applicant's community service and extracurricular activities.
  - iv. The college or university the applicant will be attending.
  - v. Other leadership activities.
3. An official high school transcript.
4. Three letters of recommendation from non-relatives. One recommendation must be from a teacher or school official.

**Section 3. Notices.** The Town Clerk is directed to post notice of the Scholarship and the application deadline at Town Hall and at the public library located in the Town. The Town Clerk shall also provide notices of the Scholarship to the principals at area schools and to the area newspapers.

**Section 4. Review and Recommendation to Council.** By no later than May 31<sup>st</sup> of each year, the Town's Education Advisory Board shall review the application packages and recommend two students to the Town Council.

**Section 5.** This Resolution shall become effective immediately upon its adoption.


Dear Robert:
