RESOLUTION NO. 02-6

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, DETERMINING THE PROPOSED MILLAGE RATE, THE CURRENT YEAR ROLLED BACK MILLAGE RATE, AND SETTING THE DATE, TIME AND PLACE FOR THE FIRST AND SECOND BUDGET HEARINGS FOR FISCAL YEAR 2002-03, AS REQUIRED BY LAW; DIRECTING THE CLERK TO FILE SAID RESOLUTION WITH THE PROPERTY APPRAISER OF MIAMI-DADE COUNTY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on July 1, 2002, Joel W. Robbins, Property Appraiser of Miami-Dade County, Florida (the "Property Appraiser") served upon the Town of Miami Lakes, Florida (the "Town") a "Certification of Taxable Value" certifying to the Town its 2002 taxable value; and

WHEREAS, the provisions of Section 200.065, Florida Statutes, require that the Town, within thirty-five (35) days of service of the Certification of Taxable Value, furnish to the Property Appraiser the proposed millage rate, the current year rolled-back rate and the date, time and place at which public hearings will be held to consider the proposed millage rate and the tentative budget.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

- Section 1. The above recitals are true and correct and incorporated into this resolution by this reference.
- Section 2. The proposed millage rate for Fiscal Year 2002-03 is declared to be 3.057 mills, which is \$3.057 per each \$1,000.00 of assessed property within the Town of Miami Lakes, Florida.
- Section 3. The current year rolled-back millage rate as computed pursuant to Section 200.065, Florida Statutes is 2.9008, which is \$2.9008 per \$1000.00.
- Section 4. That the proposed date, time and place of the first and second public hearings are set by the Town Council as follows:
