RESOLUTION NO. 03-137

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, APPROVING THE SELECTION OF DEVELOPMENT & COMMUNICATION GROUP OF FLORIDA, INC. FOR ROYAL OAKS PARK MUCK AND VEGETATION REMOVAL AND BERM CONSTRUCTION; AUTHORIZING TOWN OFFICIALS TO **FINALIZE** THE **TERMS** OF THE CONTRACT; AUTHORIZING THE TOWN MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE MAYOR TO EXECUTE THE CONTRACT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, over the past several months, the Town of Miami Lakes (the "Town") has been preparing Royal Oaks Park (the "Park") for ultimate improvements and renovations; and

WHEREAS, the Town advertised for bids on March 15, 2003, for the removal of muck and vegetation from the Park and the construction of a berm (the "Work"); and

WHEREAS, on April 4, 3003, all bids were publicly opened and read; and

WHEREAS, after reviewing all bids submitted to the Town, the Town Manager recommends the selection of Development and Communication Group of Florida, Inc. ("DCG"), as the lowest, responsive and responsible bidder.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MIAMI LAKES, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. Award of Contract. The contract for Royal Oaks Park Muck and Vegetation Removal (the "Contract"), shall be awarded to Development and Communication Group of Florida, Inc.

<u>Section 3.</u> <u>Authorization of Town Officials.</u> The Town Manager and Town Attorney are authorized to take all steps necessary to finalize the Contract with DCG.

Section 4. Authorization of Fund Expenditure. The Town Manager is authorized to expend budgeted funds, up to the amount of the Contract, to implement the terms and conditions of the Contract.

<u>Section 5.</u> <u>Execution of Contract.</u> The Mayor is authorized to execute the Contract on behalf of the Town.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
